The jurors of the Grand Jury of the State of Ohio, within and for the body of the County aforesaid, on their oaths, in the name and by the authority of the State of Ohio, do find and present that:

Count I: **Crystal Perkins**, DOB: 01/16/82, SSN: [REDACTED], between on or about the 1<sup>st</sup> day of January, 2013 and on or about the 24th day of March, 2014, at the County of Richland, Ohio, with purpose to deprive the owner, an elderly person or disabled adult, of property or services, did knowingly obtain or exert control over the property or services, beyond the scope of the express or implied consent of the owner or person authorized to give consent, the value of said property or services stolen being thirty-seven thousand five hundred dollars (\$37,500) or more but less than one hundred fifty thousand dollars (\$150,000), in violation of section 2913.02(A)(2) of the Ohio Revised Code, a felony of the second degree.

Count II: **Crystal Perkins**, DOB: 01/16/82, SSN: [REDACTED], between on or about the 1<sup>st</sup> day of January, 2013 and on or about the 24th day of March, 2014, at the County of Richland, Ohio, with purpose to deprive the owner, an elderly person or disabled adult, of property or services, did knowingly obtain or exert control over the property or services, by deception, the value of said property or services stolen being thirty-seven thousand five hundred dollars (\$37,500) or more but less than one hundred fifty thousand dollars (\$150,000), in violation of section 2913.02(A)(3) of the Ohio Revised Code, a felony of the second degree.

Contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.
