

**INDICTMENT**

STATE OF OHIO, COUNTY OF ROSS, SS:

In the Common Pleas Court of Ross County, Ohio, of the 2022 term, second fourth part, in the year of our Lord Two Thousand and Twenty-Two.

The Jurors of the Grand Jury of the State of Ohio, within and for the body of the County aforesaid, being duly impaneled and sworn and charged to inquire of and present all offenses whatever committed within the limits of said County, on their oaths, in the name and by the authority of the State of Ohio, do find and present:

**COUNT ONE:** On or between approximately October 20, 2020 and November 1, 2021 and in Ross County, Ohio, the defendant Stephanie L. Cottrell did, with the purpose to deprive Rocal, Inc., the owner, of their property (to wit: US currency \$150,000 < \$750,000), knowingly exert control over property worth \$150,000 or more, but less than \$750,000, by deception; in violation of Ohio Revised Code Section 2913.02(A)(3), a felony of the third degree, and against the peace and dignity of the State of Ohio.

**COUNT TWO:** On or between approximately April 1, 2019 and September 27, 2021 and in Ross County, Ohio, the defendant Stephanie L. Cottrell did, with the purpose to deprive, Rocal, Inc., the owner, of their property (to wit: US currency \$150,000 < \$750,000), knowingly exert control over property worth \$150,000 or more, but less than

\$750,000, by deception; in violation of Ohio Revised Code Section 2913.02(A)(3), a felony of the third degree, and against the peace and dignity of the State of Ohio.


