INVESTIGATIVE REQUEST:

Special Agent Kirkpatrick has prepared an addendum to include clarifications to the prosecutor's summary. These clarifications relate to legislative lobbying summary tables for Ron Wine and the Ron Wine Consulting Group.

Investigator's Note:

SA Kirkpatrick will note that the hours and percentages in the legislative lobbying table included in the prosecutor's summary referenced the aggregate hours worked on the Wright State University projects by all employees/sub-contractors of the Ron Wine Consulting Group. SA Kirkpatrick will also note that clarifications were made to include the conversion of raw data calculations to percentages in the lobbying summary tables.

INVESTIGATIVE FINDINGS:

The tables above were provided as an addendum to clarify the record. It should be noted that none of the revisions or clarifications changed the overall findings of the investigation. Based on the records provided to the Investigators and explanations provided by Wine on certain calendar items, neither Ron Wine nor the Ron Wine Consulting Group spent more than five percent of their time lobbying members of the legislative branch or twenty-five percent of their time lobbying members of the executive branch while working on behalf of WSU. Even if Investigators discounted Wine's explanations and only used the total hours discernable from objective evidence, the total time spent lobbying members of the legislative or executive branch still fell below the requisite totals required by the Joint Legislative Ethics Commission.
