



GUIDE TO OHIO SCHOOL VULNERABILITY ASSESSMENTS

‘A harder target’

Threat assessments focus on people, but this vulnerability assessment will focus on the physical school building. The Ohio Department of Public Safety provides a 28-section form, titled “Security and Vulnerability Assessment,” which should be used to evaluate the school’s preparedness. This training explores some of the key sections.

FACILITY INFORMATION

- Schools are considered soft targets, in that they are lightly guarded.
- Schools are locations where large numbers of people congregate.

FEATURES OF A BADGE/ID CARD

- Branding: school’s logo and colors
- Color headshot photo
- Individualized serial numbers
- Security measure: holographic image or seal
- Magnetic strip or chip for functionality

“Dependencies and Dependency Protection”

“Building Envelope”

- Nondisruptive measure
- Fortifies school without changing appearance
- Differing ballistic capabilities
- Can delay entry by attacker
- Protects against adverse weather, provides blast mitigation, limits visibility from outside

“Parking/Vehicles”

- Fences, gates and barriers
- Mitigate threat while maintaining learning environment
- Control traffic
- Must be functional during emergencies

- Aesthetically pleasing way to enhance security
- Define or designate spaces
- Deny access to unauthorized people or vehicles
- Avoid providing concealment

- Improved technology has reduced cost
- Record and store data
- Is a deterrent tool if monitored
- Able to be viewed by first responders
