<b>#2</b>	<b>DEMONSTRATE HOW TO APPLY A TOURNIQUET</b>		
	Student will demonstrate proficiency in applying a tourniquet to all the following areas:		
	His/her own arm		
	His/her own leg		
	Another student's arm		
	Another student's leg		
	Tourniquet placement		
	The tourniquet can be applied over his/her clothes; however, the instructor should ensure that any equipment (e.g., coat, body armor) or personal items (e.g., items in pockets) that impede access should be removed		
	The tourniquet should be tightened until pulses can no longer be felt		
	The student should document the time the tourniquet was placed		
<b>#4</b>	<b>DEMONSTRATE JUNCTIONAL HEMORRHAGE CONTROL</b>		
	Assess the situation		
	Determine what type of hemorrhage control is needed		
	Pack the wound with gauze or hemostatic gauze		
	Hold direct pressure for a minimum of three minutes, if possible		
	Apply trauma dressing		
<b>#6</b>	<b>DEMONSTRATE HOW TO INSERT A NASOPHARYNGEAL AIRWAY</b>		
	Use the head tilt/chin lift maneuver to open the mannequin's airway		
	Apply water-based lubricant to NPA, if available		
	Push the tip of nose upward		
	Insert the airway, pushing towards the mannequin's back, rather than up		
	Gently advance the NPA until the flange rests against the nostril		
	Roll mannequin onto its side (i.e., recovery position) or into a position of comfort		
<b>#7</b>	<b>DEMONSTRATE ETHICAL DECISION MAKING AND CRITICAL THINKING IN A PRACTICAL APPLICATION SCENARIO</b>		
	Demonstrate appropriate medical response		
	Include two or more of the practical SPOs		
	Display ethical and critical decision-making skills as they relate to the following		
	Assessing the situation		
	Assessing the casualty		
	Assessing his/her available resources		
	Analyzing possible solutions		
	Selecting the best way to manage the situation and casualty		
	Developing a plan of action		
	Initiating a plan of action		
	Reassessing the response of the casualty to the plan of action		
	Make any needed adjustments to the plan of action while getting the casualty to definitive medical care		
	Verbalize patient evacuation plan pertinent to his/her area/agency
