Gentlemen:

In accordance with Ohio Revised Code Section 109.731(D), I am pleased to present the 2006 report on Ohio's concealed handgun law. This information is provided to the Commission by Ohio's county sheriffs.

Ohio law requires the Ohio Peace Officer Training Commission to report, not later than the first day of March, the number of licenses to carry a concealed handgun that were issued, renewed, suspended, revoked, and denied in the previous calendar year, the number of applications for those licenses for which processing was suspended, and the number of temporary emergency licenses to carry a concealed handgun that were issued, suspended, revoked, or denied.

# **EXECUTIVE SUMMARY**

Ohio's law to allow citizens to carry concealed handguns went into effect on April 8, 2004. The law allows citizens with proper firearms safety training to apply with their county sheriff, or a sheriff of an adjacent county, for a license to carry a concealed handgun.

Persons who apply for a license are required to undergo a criminal history background check to ensure that they are not prohibited by law from carrying a concealed handgun. For persons who have lived in Ohio for five years or more, the sheriff submits the applicant's fingerprints electronically to the Ohio Bureau of Criminal Identification and Investigation for an in-state criminal background check. Applicants who have lived in Ohio fewer than five years are required to undergo a national check through the Federal Bureau of Investigation. Ohio law requires county sheriffs to provide statistical information about the licenses they issue to the Ohio Peace Officer Training Commission. The Commission, in turn, is required by Ohio Revised Code Chapter 109.731 to compile those statistics and report them to the Governor and the leadership of the General Assembly each year.

### **Licenses Issued**

In calendar year 2006 - the second full year Ohio's Concealed Handgun Law was in effect, Ohio sheriffs issued 18,781 licenses, a decline of 16.5 percent from the previous year and a drop of approximately 59 percent compared to the number of licenses issued between April and December 2004.

For calendar year 2005 — the first full year the law was in effect — Ohio sheriffs issued 22,487 regular licenses to carry concealed handguns. The sheriffs issued 67 temporary emergency licenses, which allow a person who submits evidence of imminent danger to receive a non-renewable 90-day license to carry a concealed handgun. That figure is 11 higher than the number issued in 2004. As of December 31, 2006 86,832 Ohioans had been issued regular or temporary licenses to carry a concealed handgun.

# Licenses Suspended

Under R.C. 2923.128 sheriffs must immediately suspend a concealed handgun license upon notification that the licensee has been arrested or charged with certain offenses, or if the licensee is the subject of a protection order issued by a court. In 2006 sheriffs suspended 352 regular licenses It is important to note that some of these licenses may have issued in previous years. In 2005, sheriffs suspended 219 concealed handgun licenses. For 2006, sheriffs revoked or suspended 2 temporary emergency licenses.

Sheriffs are not required to report the details surrounding a suspension.





### **Licenses Revoked**

That same section of the Ohio Revised Code also requires sheriffs to revoke the license of any person who no longer meets the eligibility requirements to carry a concealed handgun. In 2006, 194 regular licenses were revoked because the licensee was no longer eligible to hold a concealed carry license. The reasons for revocation vary from the death of the licensee to no longer being a resident of Ohio to a disqualifying criminal conviction to becoming subject to the law's restrictions on mentally ill person or persons considered drug or alcohol dependent. Sheriffs are not required by the law to report the specific reason for the revocation to the Peace Officers Training Commission. Again, licenses that were revoked in 2006 may have been issued in 2005 or 2004. Sheriffs are not required to report the reason for a revocation.

In 2004, 78 licenses were suspended by Ohio sheriffs under the law. In 2004, Ohio sheriffs revoked 42 regular licenses and 4 temporary emergency licenses.

### **Applications Denied**

The law requires that sheriffs shall deny an application by any person who fails to meet the eligibility criteria specified in R.C. 2923.125 for regular licenses, or R.C. 2923.1213 for temporary emergency licenses. For calendar year 2006, sheriffs denied 384 applications for regular licenses and 4 applications for temporary emergency licenses. In 2005, sheriffs denied 427 applications for regular licenses (9 fewer denials than in 2004) and 3 applications for temporary emergency licenses.





### **Reciprocity Agreements with Other States**

The law requires the Ohio Attorney General to craft reciprocity agreements with other states to allow Ohioans with permits to carry weapons in those jurisdictions and for those states' citizens to carry weapons in Ohio. These agreements require an analysis of those other laws to ensure they meet the requirements of Ohio's concealed weapons law and vice versa (ORC 109.69).
