

Dear Colleagues,

The Crime Victims Services Section of my office specializes in helping vulnerable Ohioans transition from victims to survivors. One of our most important tools is the Ohio Victims of Crime Compensation Fund, which reimburses the costs of medical expenses, crime-scene cleanup, counseling and other services that crime victims and their families need to heal and move forward with their lives.

Since 1976, the fund has paid out more than \$386 million to victims. Additionally, grant awards have been used to support the vital work provided by domestic violence shelters, prosecutor-based victim/witness programs, child advocacy centers and other similar governmental and nonprofit agencies.

In fiscal year 2020, which ran from July 2019 through June 2020, my office paid out 1,987 claims averaging \$2,825 each.

Among our other efforts in fiscal year 2020:

- We kicked off the Sexual Assault Kit Tracking System, which lets victims of sexual assault in Clark, Franklin and Summit counties track the evidence collected from them at medical centers. They can check whether police have the kits or whether the kits have been sent to a laboratory for testing – a service that continues to roll out across the state.
- The Sexual Assault Forensic Exam program reimbursed medical facilities for 7,212 exams at a cost of more than \$4.5 million. The program helps to ensure that evidence is properly collected for possible prosecution and that patients are not forced to pay extra because they were assaulted.
- Using federal Victims of Crime Act funding, my office awarded more than \$95 million in grants to 370 community agencies, including trauma recovery centers operating in Cuyahoga, Franklin, Lucas and Clark counties.
- Crime Victim Services staff members trained more than 2,100 people on a wide range of topics, including victim compensation, elder abuse, domestic violence, sexual assault and child abuse. The COVID-19 pandemic forced the cancellation of our Two Days in May Conference on Victim Assistance; we replaced it with a virtual “One Day in May” conference, which drew more than 800 victim advocates and other professionals.

Although the FY20 achievements are laudable, they did not come without heart-wrenching decisions necessitated by a climate of rapidly declining funding. In fact, the Crime Victim Compensation Fund has decreased significantly – from \$112 million in FY2018 to \$55.5 million this fiscal year, with additional cuts expected in the upcoming fiscal year.

Immediate solutions are required to ensure the long-term viability of this fund, which offers crime victims a helping hand at perhaps the most vulnerable point in their life. The fund’s financial strength is crucial to providing all Ohioans access to the assistance they need.

As such, earlier this year I joined attorneys general from all 50 states in calling on members of Congress to increase funding for crime victims. We must do all that we can to make sure that these vital resources remain available.

Per Ohio Revised Code Section 2743.69, this report details the above efforts and many others made by my office to assist crime victims and the advocates who work on their behalf. If you have questions or comments, please contact Crime Victim Services at 614-466-5610.

## Introduction

The Ohio Victims of Crime Compensation Fund was created in 1976 to help ease the financial impact inflicted on innocent victims of violent crime. Responsibility for the fund was transferred on July 1, 2000, from the Court of Claims to the Ohio Attorney General's Office. In addition to overseeing the compensation program, the Attorney General's Crime Victim Services Section administers state and federal grants to support communities' victim assistance programs and provides education and training for victims, victim advocates and the general public.

## Grants Unit

The Grants Unit of the Crime Victim Services Section administers grants from the State Victims Assistance Act (SVAA) and the federal Victims of Crime Act (VOCA), which are funded by court costs and fees, not taxpayer dollars. Recipients generally include domestic violence shelters, prosecutor-based victim/witness programs, child advocacy centers and other similar governmental and nonprofit agencies that provide direct services to crime victims.

VOCA funds provided to Ohio were down almost 10% from fiscal year 2019: Every Ohio county shared in more than \$95 million in grants, which were distributed to more than 370 organizations. Among the programs funded were:

- Trauma Recovery Centers, which provided services to victims of violence, including gun violence, robberies, assaults, sexual assault, human trafficking and other underserved crimes. These centers are operating in Cuyahoga, Franklin, Lucas and Clark counties.
- CitiLookout in Springfield and Family Services Association in Dayton, which provided behavioral health services to the victims and co-victims of a 2019 mass shooting. Hundreds of individuals were present in the Oregon District, the popular nightlife district in downtown Dayton where the attack took place, and hundreds of others were affected through a relationship with a person who was there.

The Grants Unit also administers the Rape Crisis Fund, which provided more than \$1 million to rape crisis centers. The funding is used to provide direct victim services — such as crisis response, hospital advocacy and criminal justice advocacy — to survivors of sexual assault statewide. In the current awarding period, 30 agencies received grants of \$120,744 each to assist victims. The Ohio Alliance To End Sexual Violence was awarded \$416,000 to provide training and technical assistance to rape crisis centers throughout the state.

In another of the unit's programs, Ohio's Domestic Violence Fund grants a consistent funding source to organizations that provide core services to victims of domestic violence. Examples include emergency shelter, counseling and advocacy in and out of the criminal justice system. In fiscal year 2020, 48 agencies received grants of \$17,812.50 each to assist victims. Also, the Ohio Domestic Violence Network was awarded \$95,000 to provide training and technical assistance to such programs throughout the state.

The Grants Unit also provides funding for 1-844-OHIO-HELP, a statewide sexual violence helpline started by the Attorney General's Office and operated by OhioHealth's Sexual Assault Response Network of Central Ohio. The 24/7 phone center received 518 calls in fiscal 2020.

## Victim Service Initiatives

The Victim Service Initiatives Unit:

- Provides training and technical assistance for victim services professionals and develops resources for them.
- Provides direct victim advocacy and educates communities about available crime victim support services.
- Coordinates training, special events and outreach activities by streamlining scheduling, providing registration and logistical support, and filing for continuing education credits.

The unit's 29th annual Two Days in May Conference on Victim Assistance was canceled due to the COVID-19 pandemic. A virtual One Day in May replacement conference on May 21, 2020, presented three speakers and was capped at "attendance" of 800. The Robert Denton Special Achievement, Promising Practice, Special Courage and AGvocate awards were presented to the winners.

Also canceled because of the pandemic was the five-day Basic Advocacy Skills in Crime Victim Services (BASICS) Academy.

The unit produces the Ohio Crime Victims' Rights Booklet, an explanation of the compensation and legal systems for crime victims. In 2020, the section distributed 60,000 booklets to 250 law enforcement agencies, which are required to provide a victim of a crime a written explanation of his or her rights promptly after making initial contact.

The unit also works to advance policies that secure rights and protections for victims. During fiscal year 2020, more than 2,124 people received some form of training and technical assistance from the unit in areas that included the following:

### Domestic violence/sexual assault

Crime Victim Services offers training and technical assistance throughout the state on domestic violence, stalking, strangulation, elder abuse and sexual assault investigation and prosecution. As a result, communities are seeking to improve their response to victims of violent crime and are creating better policies to collaborate with allied agencies.

In fiscal year 2020:

- Eighteen trainings were conducted in eight rural and urban regions of the state.
- About 780 multidisciplinary team members were trained by the Ohio Attorney General's Interpersonal Violence Response Training Team and national experts in Certified Forensic Experiential Trauma Interview (FETI) on the best interview methods for responding to trauma victims. Courses also included best practices in stalking response, domestic violence intervention, sexual assault investigation and prosecution, and strangulation prevention.
- Technical assistance training was provided on the Sexual Assault Forensic Exam program at three locations, and meetings on the multidisciplinary response to sexual assault were provided in three counties.
- Expert witness testimony on domestic violence was provided in two rural counties.
- The Sexual Assault Kit Tracking System was rolled out in March 2020 to three participating cities. By

June 2020, three counties — Clark, Franklin and Summit — were using the system to track kits (collected from victims of sexual assault at medical centers) through different stages, including evidence collection, laboratory processing and return to law enforcement. Victims are able to anonymously learn the status of their kit through <https://sakt.ohioattorneygeneral.gov/>, the same portal professionals use to log new developments in a kit's history or see which kits in their possession await action.

## **Sexual Assault Forensic Exam program**

The Sexual Assault Forensic Exam (SAFE) program is statutorily mandated by Ohio Revised Code Section 2907.28 to cover medical expenses for examinations of patients after a sexual assault, both to ensure the proper collection of evidence for possible prosecution and to ensure the patient is not forced to pay. The program reimbursed medical facilities more than \$4.5 million for 7,212 exams in fiscal year 2020.

In October 2017, the SAFE program began reimbursing hospitals that provide HIV-prevention treatment to victims who might have been exposed to the disease. In collaboration with the Ohio Department of Health, a risk exposure protocol was developed as part of the state's medical forensic exam process. Ohio Administrative Code Section 109:7-1-02(B) states: "A hospital, children's advocacy center, or other emergency medical facility shall accept payment of the actual amount billed; not to exceed twenty-five hundred dollars, as payment in full for any cost incurred in administration of HIV post-exposure prophylaxis protocol in rule 109:7-1-01 of the Administrative Code." The HIV program issued payments totaling \$707,450.30 in fiscal year 2020.

## **Victim Information and Notification Everyday**

The Victim Information and Notification Everyday (VINE) program helps crime victims and other concerned citizens gain access to information about the criminal cases and custody status of offenders. VINE provides information on the status of offenders within the Ohio Department of Rehabilitation and Correction, the Ohio Department of Youth Services and county jails. Individuals can register to be notified by phone, email, text or TTY device when an offender's custody status changes. Users can register through their participating state toll-free number, VINELink mobile app, VINE MobilePatrol app or VINELink.com.

In fiscal year 2020:

- On average, 142,226 online searches were conducted monthly at [www.vinelink.com](http://www.vinelink.com), the primary registration point for Ohio.
- On average, 6,099 new registrations were logged each month.
- VINELink usage decreased 19.9% over comparable 12-month periods, from 1,009,820 to 808,894.
- New registrations decreased 12.5%, from 83,692 to 73,191.
- Phone notifications decreased 37.4%, from 282,448 to 176,748.
- Email notifications decreased 9.0%, from 93,568 to 85,152.
- SMS Text Messaging Notification increased 2.9%, from 56,072 to 57,680 events.
- MobilePatrol increased 14.3%, from 770,592 to 880,541

The decreased usage, enrollments and notifications are a presumed side effect of the 2020 COVID-19 pandemic as month-to-month statistics began declining in March 2020. Several factors may be at play, including the fact that jail populations are down across the country, including in Ohio, which equates to fewer people searching for offenders.

The more concerning potential factor is that the pandemic led to decreased awareness. A large percentage of victims learn of VINE through posters, brochures, etc., at the offices of service providers and local law enforcement. Since the pandemic, interaction with advocates has decreased – victims may not have been able to go to places to get help and thus are not learning about this important option.

## **Child victim trial preparation training**

Twenty-eight enforcement officers, prosecutors, forensic interviewers and child protection professionals were trained to interview and prepare children for court through Finding Words Ohio, an intensive five-day course that teaches professionals the skills necessary to conduct competent investigative interviews of child abuse victims. The second scheduled course was canceled due to the COVID-19 pandemic.

## **Crime Victim Compensation Program**

Chapter 2743 of the Ohio Revised Code governs the compensation program, which allows applicants to be reimbursed up to \$50,000 for economic losses incurred as a result of a violent crime. Economic losses that can be recovered are:

- Medical and related expenses.
- Funeral and burial expenses (up to \$7,500).
- Dependents' economic losses resulting from the death of a victim.
- Counseling expenses for immediate family members of victims of domestic violence, sexual assault, homicide or a crime that has resulted in a severe and permanent incapacitating injury, such as paraplegia (up to \$2,500 per family member).
- Crime scene cleanup expenses (up to \$750).
- Compensation for property held as evidence (up to \$750).

Victims cannot receive compensation for pain and suffering or stolen property. Also, the program is a payer of last resort; it will not compensate for economic losses that can be recovered from another source.

In order to participate in the program, the victim:

- Must not have engaged in any conduct that substantially contributed to the injuries sustained.
- Must not have engaged in violent felonious conduct or drug trafficking within 10 years of the incident for which the claim has been filed.
- Must not have any felony convictions, domestic violence convictions or child endangering convictions within 10 years of the incident for which the claim has been filed.

## Administrative Costs

In terms of the compensation fund, administrative costs for fiscal year 2020 totaled \$6,340,783.

As noted earlier, responsibility for the compensation fund was initially in the hands of the Court of Claims. Some funding for the court continues to come from the compensation fund, including for work on appeals of decisions made by the Attorney General's Compensation Unit (ORC 2743.531). The number of appeals to the Court of Claims decreased from 33 to 22 in the fiscal year.

The costs to the Attorney General Office increased 2.5%, from \$6,188,467 to \$6,340,783. Because this involved 4,475 claims, the cost per claim averaged \$1,417.



## Application and Award Summary


The Compensation Unit processed 4,475 compensation claims in the fiscal year. The average award for claims totaled \$2,825, down from \$2,961 the year before. The total amount paid to crime victims throughout the state was \$5,614,050 in the fiscal year. The unit's goal for the upcoming year is to make more people statewide aware of the compensation program and the assistance available. (The data for fiscal year 2020 were affected by the COVID-19 pandemic beginning in March.)

## Yearly Average Processing Time (in Days)




## Yearly Compensation Payout (in Millions)



## Fund Balance for Fiscal 2011 through 2020 (in Millions)

The fund's balance had fallen in recent years, as illustrated in the chart below. Fiscal year 2020 saw an increase in the fund total of 17.0%.



The fund balance had been falling due to a combination of factors, including lower federal funding. Also, in fiscal years 2017, 2018 and 2019, almost \$1.5 million was sent each year to the Bureau of Criminal Investigation for DNA work to help solve crimes for victims; in fiscal year 2017, the SAFE program increased the amount paid to medical centers from \$532 to \$632 per sexual assault kit; and revenue provided by court costs and fees has been decreasing since fiscal year 2016.

However, in fiscal year 2020, measures were taken to secure the fund by finding another funding source for the DNA work and securing a grant to pay for the majority of the SAFE program.

## Attorney Fees

Two types of attorney fees are payable under the crime victim compensation statute.

Under ORC 2743.65, an applicant may seek the assistance of an attorney in filing for compensation or in appealing a decision of the Attorney General's Office. The \$99,998 in attorney fees paid out in the fiscal year represents a 13.7% decrease from the previous year's \$115,913.

Under ORC 2743.51(F)(4), attorneys who assist the claimant with successfully obtaining a protection order or another order to physically separate the victim from the offender may receive reasonable attorney fees not exceeding \$1,000, at a rate not exceeding \$100 per hour. Attorney fees for reasonable travel time incurred to attend court hearings are paid at a rate not exceeding \$30 per hour. The total amount paid to attorneys assisting with protection orders decreased 40.3% in fiscal year 2020, from \$390,008 to \$232,859.

## Awards by Incident Type

As in past years, the majority of the awards paid went to victims of assault (57.2%). Next were awards related to incidents of homicide (12.0%) and sexual assault (8.4%).

## Subrogation

The Attorney General holds offenders financially accountable for their crimes. The Subrogation Unit's collection efforts against offenders, insurance companies and other liable parties allow for the fund to be reimbursed. The chart below summarizes the results of the Subrogation Unit's efforts, which included returning \$481,487 to the fund in fiscal year 2020, a 27.8% increase over the previous fiscal year.
