Narrative:

On Tuesday, March 4, 2025, Ohio Bureau of Criminal Investigation Special Agent Steven Seitzman received requested records and recordings from Miami Township Assistant Chief of Police James McCarty. SA Seitzman had previously requested all dispatch records, audio recordings, mobile data terminal (MDT) communications, and any other dispatch/communications-related information related to the time period under investigation. As a result of that request, the following items were received and reviewed:

Computer-Aided Dispatch Records:

- According to the Call Detail Report, the incident was reported on February 19, 2025, at 1404 hours. It was labeled as a *Family Problem*.

"Shots fired" was entered at 1419 hours.

Police Radio Traffic Recording:

The radio traffic began with a tone. The dispatcher then said, Again, Again, We have a family problem. The son has a knife and is threatening them with it.

The dispatcher provided the name Jayden Stephenson and told the officers that he was in the living room near the front door with a knife. In subsequent transmissions, the dispatcher told the responding officers that Jayden had thrown a vase and was coming at the family with the knife.

An officer on the scene requested medics respond to the area. In a subsequent transmission, an officer indicated that less-lethal had been deployed. Shortly after, an officer broadcast that shots had been fired. The dispatcher acknowledged and said, "99," which is a county-wide officer needs assistance broadcast.

Dispatch to EMS Radio Traffic Recording:

The recording commenced with a dispatcher requesting a medic stage in the vicinity of

for a "mental health issue." The EMS dispatcher confirmed the transmission by saying "1415," presumably a reference to the time (1415 hours).

Subsequently, the dispatcher announced that shots had been fired. The EMS dispatcher advised that he was advising medics of the additional information. He followed the transmission by saying, "1420," again, presumably referring to the time (1420 hours).

The Miami Township dispatcher requested additional response from the Miamisburg Police Department to assist with securing the scene. All other police agencies were disregarded from the county-wide officer needs assistance. The Montgomery County dispatcher advised that Washington Township (Montgomery County Sheriff's Office) deputies were responding to secure the scene.

911 Call:

The 911 call audio file, approximately 9 minutes and 23 seconds in duration, revealed the tense and distressing situation occurring inside the residence. As the phone was dialing, the caller, identified as Christina Schindler, can be heard yelling something to the effect of, "Oh my gosh, Jayden." Ms. Schindler told the dispatcher that her son had just "pulled a knife." She then provided the address of She reiterated that her son had a knife in his hand. She provided the dispatcher with her son's name, Jayden Stephenson. She further told the dispatcher that Jayden broke a vase by throwing it across the room. She said he was in the living room holding the knife. She further mentioned that as he was holding the knife, he made a threatening statement, saying, "Get my car, or else." Ms. Schindler told the dispatcher that she believed Jayden was experiencing a mental health crisis. She stated that Jayden was not on any medications, though he was previously prescribed lithium.

The dispatcher requested a description of the knife from Ms. Schindler. Ms. Schindler said, "He just flipped it out. Like, it opens and closes." She then confirmed that the knife was similar to a standard pocket knife.

Ms. Schindler told the dispatcher that she, Jayden's grandmother (Terry Bennett), and Jayden's sister (Sophia Cresong) were inside the house. During the call, she said, "Now he's coming at us." The dispatcher told her to seek refuge in another room or get out of the house. Shortly after, a doorbell can be heard. Ms. Schindler said that it was her dad at the door and pleaded with Jayden to stay away from him. She then reported that Jayden was getting "really aggressive, like coming at us with the knife." The dispatcher instructed Ms. Schindler to evacuate the house, which she eventually did along with Ms. Bennett and Ms. Cresong. She confirmed that Jayden remained inside the house by himself. She further stated that no one had been hurt.


