Narrative:

On February 15, 2023, at approximately 1626 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Nick Valente (Valente) obtained records of treatment Zachary Zoran (Zoran) received from Summa Hospital pursuant to a search warrant previously served on the hospital.

The records contained two separate PDF documents. Both documents were attached to this report.

One of the documents was a single page letter certifying the other document was a true, accurate, and complete copy of the records of treatment Zoran received on December 26, 2022.

The second document was 274 pages long and documented the extent, nature, and history of Zoran's injuries. The record further provided details regarding Zoran's evaluation, treatment provided, and medications administered on December 26, 2022.

SA Valente reviewed the records and noted they were broken down into categories as follows:
