Narrative:

On Tuesday, January 7, 2025, Ohio Bureau of Criminal Investigation Special Agent Steven Seitzman received the following documents from Deputy Police Chief Ryan Morgan:

- MPD Incident Report
- [REDACTED] MDT messages
- Crime Scene Log
- City of Middletown surveillance footage of Christopher Gorak and Michael McIntosh walking through downtown Middletown prior to the officer-involved critical incident.

On Thursday, January 9, 2025, SA Seitzman received United Dairy Farmers' video footage of Gorak and McIntosh during their December 24, 2024, visit to the convenience store. Using Amped Replay, the footage files were cropped to the relevant portions of the video showing Gorak and McIntosh inside the store. [Agent's note: due to the file type, the playback speed did not match the speed in the original, proprietary files. The original files will be added to the physical case file on a thumb drive.]

The files and videos were reviewed. Nothing noteworthy was discovered. The documents are attached below. The videos were uploaded into the case folder on Axon Evidence.com.
