Narrative:

On September 8, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent Kyle Douglass (SA Douglass) received radio traffic audio files, dispatch notes and investigative reports from Blendon Township Police Department (BTPD) Lieutenant Josh Retherford (Lt. Retherford). This documentation was requested by BCI in order to investigate an Officer-Involved Critical Incident (OICI) which occurred on August 24, 2023, at 5991 South Sunbury Road in Westerville, OH. It was reported that BTPD officers were involved in an encounter with Ta'kiya Young (Young) at this location. While being confronted for an alleged theft, Young reportedly drove her vehicle towards a BTPD officer, who discharged his firearm in response. Young was transported to Mount Carmel St. Ann's medical center with an alleged gunshot wound, where she was later pronounced deceased.

Documentation received included radio traffic audio files and BTPD investigative report #02-23-000619.

After reviewing investigative report #02-23-000619, SA Douglass noted the following:

- Narrative: "Listed items were stolen from the victim."
- Offenses – Ta'kiya Young
 - Count 1 – F1 – 2911.01(A)(3) Aggravated Robbery
 - Count 2 – M1 – 2913.02(A)(1) Misdemeanor Theft
- Two unknown suspects
