Narrative:

On June 5, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agents (SA) Joe Lamping, SA John Tingly, and SA Nick Valente met with the Sheriff of Knox County, Daniel Weckesser, and Chief Deputy Richard Miller (Chief Miller) in reference to an Officer Involved Critical Incident (OICI) that occurred on June 5, 2025. During the meeting, Chief Miller provided the agents with several files regarding individuals possibly involved in the OICI. The files are attached to this report. The file regarding Lloyd Ray was reviewed in the prior law enforcement contacts report. Additionally, agents were provided with 911 CAD records which were reviewed in the associated report.

The files related to Jerrad Ray, Rebecca Hart, John Campian, and Laurretta Beltz did not contain any information relevant to this investigation.
