On 6/12/21 at approximately 0039 hrs. Off. Schmidt and I, Off. J. Emory, were dispatched to 221 W. Johnny Lytle Av. on a report of a Denajahrae Wells (Victim) being beaten up by an Eric Cole at a different location.

Upon arrival Officers observed Denajahrae Wells sitting on the front porch of the residence crying. Ms. Wells had swelling on her forehead and her left cheek. Ms. Wells stated that her entire face hurt and that the back of her head hurt from Eric Cole (suspect) pulling her hair. Officers observed that there was scratched on the right side of Ms. Wells neck that was bleeding.

Ms. Wells stated that Eric Cole and herself had a couple drinks at the 425 club tonight and that they then traveled to Burger King 2209 S. Limestone St. to get food. Ms. Wells was driving the car and Eric Cole was in the front passenger seat of the vehicle. Ms. Wells stated that Eric Cole then attempted to get into an argument with someone at Burger King so they left and went to McDonalds on S. Limestone. Eric Cole got out of the vehicle in the alleyway behind McDonalds. Ms. Wells stated that she argued with Eric Cole to get back into the vehicle because he was intoxicated and she did not want him walking to his residence at 1407 S. Center Blvd. Eric Cole then got back into the vehicle and Ms. Wells started driving him to his residence.

Ms. Wells stated that while en-route to the residence Eric Cole became more hostile in his manner of speaking and then struck Ms. Wells multiple times in the face with a closed fist. Ms. Wells stated that once they were back at Eric Cole's residence he exited the vehicle and started to walk away. Ms. Wells stated that Eric Cole then walked behind the vehicle so that she could not back up and leave his residence. Ms. Wells stated that Eric Cole then came to the driver's side window that was down and struck her multiple times in the face again with a closed fist. Ms. Well stated that Eric Cole then opened the car door and grabbed her by the hair/neck and leg and attempted to pull her out of the vehicle. Ms. Wells stated she managed to get away and drive the vehicle to her residence.

Ms. Wells was transported to Springfield Regional Medical Center by medics for treatment for her injuries. Photographs were taken of the
