**Narrative:**

On September 7, 2024, Chad Evangelista (Evangelista) was arrested by the Fairfield County Sheriff's Office (FCSO) for disorderly conduct and obstructing official business and transported to the Fairfield County Jail. Use of force was used multiple times during the arrest and at the jail. Following the interaction with law enforcement, Evangelista lost consciousness inside his cell. Evangelista was transported to Fairfield Medical then transferred to Riverside hospital where he later died on September 9, 2024.

Two agencies assisted FCSO during Evangelista's arrest at 720 W. Waterloo St., Canal Winchester, OH. Those agencies included a Franklin County Sheriff deputy and multiple Lithopolis Police officers. No law enforcement personnel were injured during the incident. Video footage of the incident was captured on both body-worn cameras and jail cameras from all agencies.

On September 10, 2024, the Fairfield County Sheriff's Office (FCSO) requested the Ohio Bureau of Criminal Investigation (BCI) to investigate an Officer-Involved Critical Incident that occurred at the Fairfield County Jail. BCI Special Investigation Unit (SIU) Special Agents Aja Chung and James Poole were assigned to investigate the incident. Dispatch records, body-worn camera, and jail footage were given to BCI by FCSO and will be among the items reviewed as part of this investigation.
