On Thursday, August 25, 2022, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Jon Lieber (Lieber) completed uploading the case file for BCI case 2022-0826 to the Ashtabula County Prosecutor's Office file system.
