Narrative:

On Thursday, October 24, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) John Tingley (Tingley) reviewed body-camera video and dash camera footage provided by the Akron Police Department (APD). The video footage is related to the officer involved critical incident which took place on August 17, 2024, in the area of 2215 East Avenue, Akron, Summit County, Ohio. The incident involved members of the APD and Michael Jones (Jones) and resulted in the death of Jones.

The listed narrative is a synopsis of the activities and conversations recorded on the one hundred and forty-one (141) body worn camera and dash camera videos from multiple APD Officers and only documents those activities which the author deems to be the most relevant. Furthermore, the narrative does not cover all of the activities or conversations of the officers which were recorded. Nor is the synopsis a word-for-word translation of the conversations or comments made by the Officers. All of the video recordings were reviewed, however, many of the video recordings did not provide any useful information related to the officer involved critical incident. Furthermore, there were eight videos (8) which have been documented in separate reports. All of the video recordings will be listed with brief descriptions of the pertinent information, if any, obtained. It is suggested that the full recordings be reviewed to clarify any content or contextual questions regarding the information documented in the narrative.

The videos recordings will be listed individually with two separate identifiers. The first identifier will be the video recording description as listed on Evidence.com for this incident. The second identifier will be of the descriptor as listed on the actual AXON

This dash camera video recording is 00:52 in length and begins on August 17, 2024, at 06:28:59 hours. The video began with the APD cruiser following a flatbed tow truck which was transporting the stolen U-Haul which Jones was driving during the incident.

At approximately 06:29:28 hours, the APD cruiser and the tow truck arrived at the APD facility at 800 Dan Street, Akron, Summit County, Ohio, where the U-Haul was stored in a locked garage, which had video security surveillance cameras. It should be noted that SA Tingley followed the tow truck and the APD cruiser from the scene of the officer involved critical incident at 2215 East Avenue to the APD facility.
