Narrative:

On Thursday, July 29, 2021, at approximately 1901 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Andrew Harasimchuk (Harasimchuk) was contacted by BCI Special Agent Supervisor (SAS) David Posten (Posten). SAS Posten requested that SA Harasimchuk respond to 300 Wood Street, Apartment A8, Mansfield, Richland County, Ohio 44903, to assist the Mansfield Police Department in an officer-involved critical incident investigation. SAS Posten advised SA Harasimchuk that the BCI Crime Scene Unit had also been requested to respond to this location.

While en route to this location, SA Harasimchuk was contacted by SAS Posten. SAS Posten requested that SA Harasimchuk respond to the Mansfield Police Department, located at 30 N. Diamond Street, Mansfield, Ohio 44902, instead of 300 Wood Street.

On Thursday, July 29, 2021, at approximately 2209 hours, while at the Mansfield Police Department, SA Harasimchuk collected six items of evidence from Cindy Reed (Reed) of the Mansfield Police Department. A Mansfield Police Department Property and Evidence Voucher was completed and added as Attachment #1 to this report. Refer to Attachment #1 for further details.

On Thursday, July 29, 2021, at approximately 2256 hours, while at the Mansfield Police Department, SA Harasimchuk collected two items of evidence from BCI SA Cory Momchilov. A BCI Inventory/Receipt Attachment was completed and added as Attachment #2 to this report. Refer to Attachment #2 for further details.

On Thursday, July 30, 2021, at approximately 0153 hours, while at 300 Wood Street, SA Harasimchuk collected 36 items of evidence from BCI SA Ed Staley (Staley). A BCI Evidence Log was completed and added as Attachment #3 to this report. Refer to Attachment #3 for further details.
