#### Narrative:

On Thursday, February 20, 2025, Ohio Bureau of Criminal Investigation Special Agent Steven Seitzman received a phone call from Alan Statman, who identified himself as the attorney representing Christina Schindler. Mr. Statman informed SA Seitzman that two spent casings had been discovered by a restoration company, which had been engaged to clean the scene of the incident. Mr. Statman advised that the casings were located in the upstairs bedroom where the incident occurred. He later provided SA Seitzman with contact information for the restoration company.

On the same date, SA Seitzman contacted Charlie George, the Operations Manager for DryMaxxOhio. Mr. George confirmed that he located two spent casings in the bedroom of the residence. He advised he would meet SA Seitzman at the residence on Friday, February 21, 2025.

On Friday, February 21, 2025, at approximately 1300 hours, SA Seitzman met with Mr. George at Miami Township, Montgomery County, Ohio. He showed SA Seitzman where the casings were discovered. SA Seitzman collected the casings, photographed them, and placed them in a manila evidence envelope. Mr. George sent SA Seitzman photographs showing where the casings were located. The photographs are attached to this investigative report.

On the same date, SA Seitzman contacted BCI Crime Scene Technician Holly Ryczek. CST Ryczek requested that SA Seitzman secure the evidence until Monday, February 24, 2025. SA Seitzman secured the evidence in a safe location and later turned it over to CST Ryczek on Monday, February 24, 2025, at approximately 0810 hours.
