**Summary:**

On June 30, 2022, Special Agent Cory Momchilov of the Ohio Bureau of Criminal Investigation received a warrant to search the contents of the below listed item. This item was to be analyzed for evidence relating to the crimes of Felonious Assault, Obstructing Official Business, and Failure to Comply regarding the subject Jayland Walker.

**Submitted Items:**

114 – Mobile Phone – Samsung Galaxy A52 5G – SM-A526U

**Details:**

**Item 114:** Item 114 is a Samsung manufactured mobile phone model SM-A526U (Galaxy A52 5G) bearing the International Mobile Equipment Identity (IMEI) number 350183734272370. The serial number associated with Item 114 is R5CRA1L18VE. Item 114 has an advertised internal storage capacity of 128 Gigabytes (GB) and is capable of additional storage through the use of a micro Secure Digital (SD) card. No additional storage was submitted with Item 114. Item 114 was already placed into Airplane mode to suspend wireless communications. The device was connected to a forensic tool capable of obtaining a file system from the device. The extraction was then loaded into Cellebrite Physical Analyzer, a software package that converts the data to an easily readable format.

**Item 114a:** Item 114a is a T-Mobile branded Subscriber Identity Module (SIM) card bearing the Integrated Circuit Card Identifier (ICCID) 8901260081940095959.

**Findings:**

**Item 114:** The Google account associated with Item 114 is jaylandwalker20@gmail.com. Attachment A contains five (5) spreadsheets that detail information recovered from Item

114. These spreadsheets include: call history, device locations, searched items, user accounts, and Web history. Attachment B contains Item 114's chats, contacts, emails, and instant messages. Attachment C contains thirty-seven (37) documents, fourteen thousand three hundred eighty-nine (14,389) graphic files, and five (5) video files recovered from Item 114.

Attachment D contains one (1) Cellebrite UFDR file. In order to view the content of the UFDR file double-click the CellebriteReader.exe and the UFDR will auto populate. Once the Cellebrite Reader is open the content can be examined and any additional reports can be generated.
