**Narrative:**

On March 19, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agents made individual requests to non-involved, supporting law enforcement agencies for copies of body-worn camera (BWC) videos and any incident reports related to the officer-involved critical incident that happened earlier that morning on I-75 near mile marker 14 in the jurisdiction of Evendale. Requests were made to the following agencies who arrived in support: Wyoming, Evendale, Hamilton County Sheriff's Office, West Chester, Sharonville, and Cincinnati (CPD). CPD advised they will require a public records from BCI to release. All other agencies voluntarily agreed to assist BCI and are complying with the request.

Cincinnati PD Assistant Chief Maurice Robinson further advised BCI that only CPD officers Vanessa Stewart and Justin Shields responded to the incident, and as they arrived after the shooting, no CPD incident reports were being created. On April 8, 2025, SA Hornyak also verified with the Hamilton County Sheriff's Office (HCSO) that no incident report had been created by HCSO personnel relating to this incident.

The public records request for the CPD BWC footage has been submitted by BCI and is awaiting fulfillment by CPD.

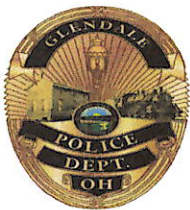

## Narrative

### Daily Activity Narrative

ON 3/19/25 AT APPROXIMATELY 0244 HOURS AN EVENDALE OFFICER LOCATED THE CAR FROM AN EARLIER WEST CHESTER PURSUIT ON EVENDALE DRIVE SOUTH.I ADVISED I WOULD BACK HIM UP TO CLEAR THE CAR .I SEEN A MALE, BLACK WALKING ON GLENDALE MILFORD ROAD HEADED WEST NEAR IR 75 NORTH.I STOPPED AND TRIED TO TALK TO THE SUBJECT AND HE WENT OVER THE GUARD RAIL AND I GRABBED HIS GREY SWEATSHIRT AND HE BROKE FREE. I ADVISED OVER THE RADIO THAT I WAS IN A FOOT PURSUIT OF A MALE BLACK WEARING A GREY SWEATSHIRT BLACK PANTS RUNNING WEST IN THE WOODS TOWARD IR 75.OTHER UNITS RESPONDED AND THE SUBJECT WAS CAUGHT A FEW MINUTES LATER SOUTH OF THE WOODS ON GENERAL ELECTRIC PROPERTY.

EVENDALE ADVISED ALL THE CAR DOORS WERE OPEN AND OTHER SUSPECTS MIGHT BE OUTSTANDING. HAMILTON COUNTY K9 OFFICER RESPONDED TO MY LOCATION AND ASKED ME TO FOLLOW HIM AND CHECK FOR OTHER SUSPECTS.I ADVISED DISPATCH WE WOULD BE CHECKING THE AREA AND STARTED IN THE WOODS AND CREEK BETWEEN AVIATION WAY AND IR 75.

AT APPROXIMATELY 0309 HOURS A LOCKLAND OFFICER ADVISED A MALE WAS WALKING ON NORTH IR 75 AT THE 14 MILE MARKER AND THE K9 AND I WALKED UP AND OVER THE GUARD RAIL. WE TRIED TO FIGURE OUT WHERE THE SUBJECT WAS WALKING IN RELATION TO OUR LOCATION.I HEARD OVER THE RADIO THAT THE SUBJECT HAD SOMETHING IN HIS HANDS AND NOT COMPLYING. AT 0311 HOURS I HEARD OVER THE RADIO TO STEP IT UP AND WE STARTED TO RUN TO HIS LOCATION. I ADVISED OVER THE RADIO THAT WE WERE 100 YARDS NORTH OF HIS LOCATION. I WAS ABOUT 40 YARDS AWAY WHEN I HEARD MULTIPLE SHOTS. I SEEN THE SUBJECT LAYING FACE DOWN AND WALKED UP AND TRIED TO ADMINISTER FIRST AID BY ROLLING HIM OVER ON HIS BACK AND TRYING TO FIND WHERE HIS WOUNDS WERE.I DID NOT SEE ANY BLOOD AND I TRIED TAKING HIS VEST OFF.I DID HEAR THE SUBJECT SIGH AND I ASKED WHERE HE WAS SHOT AT? THE SUBJECT NEVER REPLIED AND I FINALLY WITH HELP OF ARRIVING OFFICERS WAS ABLE TO REMOVE HIS VEST AND CLOTHING. OFFICERS OBSERVED A GUNSHOT WOUND IN THE CHEST AREA AND I WAS HANDED A CHEST SEAL FROM A SHARONVILLE OFFICER. I PLACED THE SEAL ON THE WOUND AND NOTICED THAT THE SUBJECT WAS NOT BREATHING.I STARTED CPR AND THE SUBJECT RESPONDED AND I PAUSED AND THEN HE WENT UNRESPONSIVE AGAIN.I CONTINUED CPR AND THEN A CINCINNATI OFFICER TOOK OVER . I STAYED ONSCENE UNTIL BCI INTERVIEWED ME AND WENT BACK IN SERVICE AT 0610 HOURS.

**Initial Narrative By Andrew Oeters, 03/19/25 03:24**

On 03/19/25 at 0223 hours, I received a Flock notification of a stolen blue Hyundai Elantra bearing (OH JGD3144) that hit in the area of Union Centre Blvd. and Muhlhauser Rd.

At this time, I was on routine patrol in my marked patrol cruiser in the area of Muhlhauser Rd. and International Blvd. traveling eastbound. At approximately 0224 hours, I observed a blue Hyundai traveling westbound on Muhlhauser Rd. As I was attempting to catch up to the vehicle, it began speeding up and traveling in between the two eastbound lanes. At this time, I was able to confirm the vehicle's license plate matched the stolen vehicle Flock hit. I notified dispatch of my traffic stop as we were approaching westbound Muhlhauser Rd. and SR-747. Right before I initiated the overhead lights of my marked patrol cruiser signaling a traffic stop, the vehicle ran the red light at the intersection of Muhlhauser Rd. and SR-747.

At this time, I notified dispatch that the vehicle was taking off southbound SR-747. I activated my BWC and emergency sirens. As we approached SR-747 and Provident Dr. there was light traffic, speeds were approximately 80 mph. P.O. Fuller entered the pursuit and took over communications. The vehicle continued southbound on SR-747 and entered



275 westbound. It should be noted that at the traffic light to enter onto the 275 westbound entrance ramp the vehicle ran another red light. While on 275 westbound, speeds were approximately 90 mph with light traffic. We continued 275 westbound until the vehicle slowed down to 50 mph and exited the highway at Route 4. The vehicle exited 275 and continued southbound on Route 4. They began to slow down and made a U-turn to enter back onto 275 eastbound from Route 4. While pursuing the vehicle on 275 eastbound, speeds reached approximately 110 mph. The vehicle exited 275 eastbound at the Mosteller Rd. exit and ran another red light. We continued to pursue on Mosteller Rd. passing East Kemper Rd. Speeds were approximately 100 mph.

At this time, Sgt. Parrett terminated the pursuit due to speeds being 100 mph. The pursuit was terminated just south of East Kemper Rd.

After terminating the pursuit, Sharonville PD reinitiated the pursuit at Mosteller Rd. and East Sharon Rd.

It should be noted that during the pursuit traffic was light to none, the roadway was lit, speeds reached approximately 110 mph, and no adverse weather conditions.

Dispatch advised that units in Hamilton County were tracking the suspects from the vehicle after they bailed out of the vehicle. Dispatch provided me with P.O. Schramm from Evandale PD's public service.

At 0300 hours, I public serviced P.O. Schramm from extension 2014. He advised that they had one suspect in custody. The suspect was identified as Charles Jackson Jr. P.O. Schramm advised that Charles stated he was just a passenger in the vehicle. I requested P.O. Schramm to public service me if they get any of the other suspects in custody. It should be noted that the vehicle crashed into a guard rail at South Evendale Dr. and Glendale Milford before the suspects bailed out on foot.

I believe there were at least 3 occupants in the vehicle because I could see a head in the rear window. However, I was not able to see who was driving.

I request this case back for follow-up to make contact with Charles and try to identify who was driving the vehicle.

### **Supporting Narrative By Logan Fuller, 03/19/25 03:36**

On March 19th, 2025 at 0223 hours FLOCK alerted to a stolen blue 2018 Hyundai Elentra with Ohio registration JGD3144 south bound on Muhlhauser Road at Union Centre Blvd.

I was traveling north bound on SR 747 near Peter Place when Officer Oeters initiated a traffic stop on the stolen vehicle at Muhlhauser and SR 747 at 0225 hours. The vehicle immediately fled south bound on SR 747 from Muhlhauser Road at a high rate speed. I entered the pursuit south bound SR 747/Peter place as the secondary unit and took over communications.

Officer Oeters and I both had our overhead emergency lights and sirens activated. My BWC was activated as well. The pursuit continued south bound on SR 747 at roughly 100 MPH. The vehicle then ran the red light at SR 747 and 275 West with no traffic present. The pursuit then continued onto 275 West. Traffic was light and speeds were roughly 90 MPH on 275 West. The vehicle then took the route 4 exit from 275 west and continued south bound on route 4. The vehicle then made a U- Turn at south bound route 4 and 275 East and entered 275 East from route 4. The pursuit then continued on 275 east with light traffic. Speeds varied between 100-110 MPH. The vehicle then took the Mosteller Road exit from 275 East. At the bottom of the exit ramp, the vehicle ran the red light at Mosteller Road and the 275 East exit ramp with no traffic present. The pursuit continued south bound on Mosteller Road. The pursuit was then terminated south bound on Mosteller Road just south of Kemper Road due to speeds being over 100 MPH.

A short time later, Hamilton County units got into pursuit with the vehicle. Please refer to officer Oeters narrative for details of his communications with Lockland PD.

There were no adverse weather conditions during the pursuit with lighted roadways.

This concludes my involvement in this case.

### **Supporting Narrative By Andrew Oeters, 04/01/25 05:06**

On 03/31/25, I contacted Evendale PD to see if they had apprehended any of the other occupants of the vehicle.



However, the Officer I spoke to was not able to see that information. She informed me that Det. Trame had been assigned the case. She provided me with his email address.

On 04/01/25, I contacted Det. Trame to see if they had any suspect information.

I request this case back for follow-up.

While on 275 westbound, speeds were approximately 90 mph with light traffic. We continued 275 westbound until the vehicle slowed down to 50 mph and exited the highway at Route 4. The vehicle exited 275 and continued southbound on Route 4. They began to slow down and made a U-turn to enter back onto 275 eastbound from Route 4. While pursuing the vehicle on 275 eastbound, speeds reached approximately 110 mph. The vehicle exited 275 eastbound at the Mosteller Rd. exit and ran another red light. We continued to pursue on Mosteller Rd. passing East Kemper Rd. Speeds were approximately 100 mph.

At this time, Sgt. Parrett terminated the pursuit due to speeds being 100 mph. The pursuit was terminated just south of East Kemper Rd.

After terminating the pursuit, Sharonville PD reinitiated the pursuit at Mosteller Rd. and East Sharon Rd.

It should be noted that during the pursuit traffic was light to none, the roadway was lit, speeds reached approximately 110 mph, and no adverse weather conditions.

Dispatch advised that units in Hamilton County were tracking the suspects from the vehicle after they bailed out of the vehicle. Dispatch provided me with P.O. Schramm from Evandale PD's public service.

At 0300 hours, I public serviced P.O. Schramm from extension 2014. He advised that they had one suspect in custody. The suspect was identified as Charles Jackson Jr. P.O. Schramm advised that Charles stated he was just a passenger in the vehicle. I requested P.O. Schramm to public service me if they get any of the other suspects in custody. It should be noted that the vehicle crashed into a guard rail at South Evendale Dr. and Glendale Milford before the suspects bailed out on foot.

I believe there were at least 3 occupants in the vehicle because I could see a head in the rear window. However, I was not able to see who was driving.

I request this case back for follow-up to make contact with Charles and try to identify who was driving the vehicle.

On March 19th, 2025 at 0223 hours FLOCK alerted to a stolen blue 2018 Hyundai Elentra with Ohio registration JGD3144 south bound on Muhlhauser Road at Union Centre Blvd.

I was traveling north bound on SR 747 near Peter Place when Officer Oeters initiated a traffic stop on the stolen vehicle at Muhlhauser and SR 747 at 0225 hours. The vehicle immediately fled south bound on SR 747 from Muhlhauser Road at a high rate speed. I entered the pursuit south bound SR 747/Peter place as the secondary unit and took over communications.

Officer Oeters and I both had our overhead emergency lights and sirens activated. My BWC was activated as well. The pursuit continued south bound on SR 747 at roughly 100 MPH. The vehicle then ran the red light at SR 747 and 275 West with no traffic present. The pursuit then continued onto 275 West. Traffic was light and speeds were roughly 90 MPH on 275 West. The vehicle then took the route 4 exit from 275 west and continued south bound on route 4. The vehicle then made a U- Turn at south bound route 4 and 275 East and entered 275 East from route 4. The pursuit then continued on 275 east with light traffic. Speeds varied between 100-110 MPH. The vehicle then took the Mosteller Road exit from 275 East. At the bottom of the exit ramp, the vehicle ran the red light at Mosteller Road and the 275 East exit ramp with no traffic present. The pursuit continued south bound on Mosteller Road. The pursuit was then terminated south bound on Mosteller Road just south of Kemper Road due to speeds being over 100 MPH.

A short time later, Hamilton County units got into pursuit with the vehicle. Please refer to officer Oeters narrative for details of his communications with Lockland PD.

There were no adverse weather conditions during the pursuit with lighted roadways.

This concludes my involvement in this case.

## 03/19/25 (Wednesday)

At approximately 2:26 this morning, West Chester units were in pursuit of a reported stolen vehicle (blue Hyundai Elentra OH plate JGD3144) and chased it into our jurisdiction to the area of Mosteller and Sharon before calling off their pursuit. Otte was parked in the Shaheen's Uniform lot when he observed the suspect vehicle, at the intersection of Sharon and Mosteller. Otte attempted to traffic stop the vehicle but terminated his effort to stop it when the vehicle turned south onto Medallion Dr. into Evendale and continued on. A few minutes later, Evendale units located the suspect vehicle crashed out at the dead end of Evendale Dr. near GE. Glendale P.O. Barnell responded to the area and called out that he saw a subject running into the tree line at Glendale Milford and Aviation Way. Sharonville units, along with several other agencies, assisted with a perimeter around the GE area at Aviation Way and Glendale Milford due to Evendale's belief that up to four subjects may have fled the wrecked vehicle due to all four doors being opened. One black male subject was located and detained near the crash site. The K-9 search of the area did not find any other suspects. Evendale units identified the detained subject and released him after he was complaining of breathing issues and transported by Evendale EMS to Bethesda North Hospital.

At approximately 02:46 hrs, a Lockland unit was coming up N/B 75 from their jurisdiction to assist when he observed a black male walking S/B on 75 near the 14.0 mile post. The Lockland unit was heard on the radio advising that the subject was refusing his commands to stop and kept moving towards the Lockland unit with something in his hands. Lockland called for assistance and a couple of minutes later approximately five shots were heard at the search perimeter before the Lockland unit called out on the radio that shots were fired. Otte and Ashcraft were enroute to the Lockland unit when he called for assistance but not on scene until soon after the shooting (Ashcraft and Otte did not witness the shooting). Ashcraft called out on the radio that CPR was in progress while Otte used items from his cruiser's IFAC bag to render aid to the shot subject. Later during a debrief, they advised the subject was shot in the leg and chest. Shooting subject was pronounced dead at the scene by responding medics. Ashcraft advised that Lockland and Evendale decided that BCI should be called in to investigate the officer-involved shooting. This was the extent of Sharonville's involvement in the incident.

On 3-19-2025 at 0244 hours, Evendale PD located a blue Hyundai Elantra bearing OH- JGD3144 that was reported as stolen out of Cincinnati PD. This vehicle fled earlier from West Chester and Sharonville PD. The vehicle was located at Glendale-Milford Rd and Aviation Way intersection. While on scene, [REDACTED] stated he had a subject walking N/B on IR-75 near the 14.0 MM. [REDACTED] advised the subject was not complying with commands and had something in his hands. He then asked for responding officers to "step it up" to assist due to the subject approaching him and had the male at gun point. At this time, I left the above intersection and started responding to his location [REDACTED] then stated "shots fired" over the radio.

Once I arrived on scene, I approached the male subject that was lying on the ground who was unresponsive. Other responding officers started cutting the male clothes off to attempt to locate any injuries. We located a GSW to the male's chest and left leg. We placed a chest seal over the GSW and I applied a tourniquet to the male's left leg. CPD officer initiated CPR until EMS arrived on scene. Once EMS arrived on scene, EMS handled from this point on.

While on scene, I located several shell casings on the ground. I notified the SGT deputy on scene of the findings. The casings were then marked by the SGT deputy. This concludes my involvement at the scene.

On Wednesday, March 19, 2025 at approximately 0309 hours, officers responded to the area of the 13.9-mile post of northbound IR-75 for a Lockland police officer needing assistance. Evendale Officer Andrew Schramm arrived on scene shortly thereafter and learned that a subject, later identified as Samuel Munyarutete, was deceased on the right berm after an encounter with the Lockland police officer. The Lockland officer was no longer at the scene and had already been transported to his respective police station. Upon learning the initial details of the incident, Officer Schramm notified multiple Evendale officers and requested assistance with the investigation. These notifications included:

Upon arrival, the above officers assisted with traffic posts and crime scene security. The Ohio Bureau of Criminal Investigation (BCI) was requested by Lockland Police Department to respond to the scene to conduct an independent Officer-Involved Critical Incident investigation. Representatives from the Hamilton County Prosecutor's Office, as well as Chief Coroner Investigator Maria Stewart, also responded to the scene to assess the incident. Upon completion of the crime scene being processed by Ohio BCI, the decedent's body was transported to the Hamilton County Coroner's Office and the scene was cleared.
