#### Narrative:

On Monday, April 21, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Andrew Harasimchuk received an email from Alisha Bazley, Office Administrator for the Richland County Prosecutor's Office. This email contained the following attachment: OIS BCI 2024-3257.

SA Harasimchuk reviewed this attachment and noted the following:

Prosecutor Jodie Schumacher (Prosecutor Schumacher) completed the review of the investigative case file. Based on this review Prosecutor Schumacher determined that Sergeant Shane Gess, Sergeant Joseph Gladden, Sergeant Michael Haines and Officer Paul Webb's actions, regarding the officer-involved critical incident that occurred in Mansfield, Ohio, on October 19, 2024, were justified. Prosecutor Schumacher also stated that the investigation into this matter was closed.

On April 29, 2025, all evidence in this case has been returned to the requesting agency. The evidence was picked up by Mansfield Police Department Lieutenant Robert Skropits. An evidence receipt was completed and added as an attachment to this report.

Special Agent Harasimchuk and Special Agent Supervisor Charles Moran reviewed this investigation and discussed the documentation. During this discussion, it was determined that the investigation was sufficiently pursued and all investigative efforts and aspects of this case have been completed. Special agent assistance is no longer required by the requesting agency.
