Notes On 6/24/2020 Officer Hatfield #2377 of CRT-1 was flagged down on a complaint of an older man in his 60's who was driving around a juvenile who was drugged or passed out in the front seat. The complainant stated that he comes through the drive thru almost every day. The female always looks out of it and he never even lets her talk. If she does attempt to talk he will start yelling at her and throwing things in the car. The complainant felt so strongly about the situation that she took a photo of the license plate on the vehicle. The Ohio Tag #HXT-7435 came back to a Dark blue 2019 Infinity Q50. The citizen thought that she might be being drugged or being held against her will.

Officer Hatfield contacted Officer Sampson #2099 who works as part of CRT-1 but was currently temped out to the Pact Unit who deals primarily with street prostitution. Officer Hatfield relayed the information to Officer Sampson who looked into the owner of the vehicle and the residents at 1062 Oberlin Dr. Officer Sampson found that Billy Wadley and Dystanie Lydelle were registered to that address. Ms. Lydelle was 22 years old and Mr. Wadley was 63 years old. Ms. Lydelle had a history of theft, drugs and prostitution. Mr. Wadley former swimming coach for the OSU men's swim team had two prior stops that appeared to be prostitution related.

On 6/25/2020 Officer Sampson located the house and observed Mr. Wadley and Ms. Lydelle exit the vehicle and Ms. Lydelle was carrying a fast food bag. Ms. Lydelle was dressed like a prostitute and was wandering around in the front yard for a short time before going into the house.

Officers Hatfield, Cao #2357 and Stafford #2405 from CRT-1 who were operating in Marked Columbus Police Cruisers attempted to make contact with Mr. Wadley and Ms. Lydelle. Officer Hatfield knocked on the door several times but no one answered the door.

On 6/26/2020 Officer Sampson and Hatfield researched the incident further and found the following runs.

On 6/08/2020 An employee from urgent care, called the police because they had a highly intoxicated female that had a broken jaw a broken wrist and possible missing teeth that was dropped off out front. The employee believed that this was from an abusive domestic relationship so they called the police. The employee had seen Ms. Lydelle on other occasions with similar injuries. Ms. Lydelle refused a squad transport to the hospital. Ms. Lydelle contacted Mr. Wadley who came and was said to take her to

Riverside Hospital. Both Ms. Lydelle and Mr. Wadley stated that she was drinking wine late at night and fell down the steps.

On 6/15/2020 A Female called the police from [REDACTED] who was crying. The female was telling the male that he broke her jaw and her arm and that she had bruises on her legs. The female then stated that he pushed her down the stairs. The male in the background stated that she fell down the stairs. Officers arrived and there was no answer at the door. Incident # (200434584)

On 6/22/2020 A Female called the police from [REDACTED] and gave a partial location before getting disconnected. Officers arrived at 11:40pm and didn't see anything. Incident # (200455832)

On 6/26/2020 Officer Sampson who was operating in a plain clothes capacity observed Mr. Wadley pull up to 1062 Oberlin and pick up Ms. Lydelle. Officer Sampson followed them to the intersection of Wheatland and Safford Ave on the Westside of Columbus. Mr. Wadley pulled to the curb and Ms. Lydelle quickly exited and walked a few houses north. This is common for narcotics purchasers to park away from the dope house to conceal the location of the house. Ms. Lydelle went to 629 S. Wheatland and stayed less than 2 minutes then walked south on S. Wheatland and disappeared into the Alley and out of Officer Sampson's view. Ms. Lydelle returned approximately 10 minutes later and got into the vehicle and Mr. Wadley immediately pulled out.

Officer Hatfield made a stop on the vehicle at Mound St and Whitethorne Ave. Ms. Lydelle immediately started reaching around in her purse and around the vehicle. Officer Hatfield observed that she had a bindle in her hand which was empty. Her cellphone had white powder on it and she had a snort straw with it.

Officer Sampson spoke with Ms. Lydelle and asked her about her injuries. Ms. Lydelle stated that her arm was broken in 3 places. Her arm was swollen deformed and black and blue from her wrist to her elbow. Ms. Lydelle could barely move her fingers or rotate her wrist. Ms. Lydelle stated that she fell down the steps and had a cast but it slid off so she didn't get a new one. Ms. Lydelle stated that she needed to schedule surgery for her jaw because it was broken too from the fall. Ms. Lydelle have bruises on her lower legs.

Ms. Lydelle stated that she no longer prostitutes and Mr. Wadley is like her boyfriend. Ms. Lydelle was very vague on how they met. She stated they met through a friend. Ms. Lydelle has lived at 1062 Oberlin since Aug 2019. Officer Sampson asked about the calls to 911 about Mr. Wadley breaking her jaw. Ms. Lydelle stated that she didn't realize the phone dialed the number and admitted to making the call. Ms. Lydelle stated the call was just during an argument. Ms. Lydelle stated that just she and Mr. Wadley live at the residence. Ms. Lydelle stated that she has been on Suboxone for approximately a year and was only out on the Westside to meet with her mother who is in poor health and a drug addict to drop off food. Officer Sampson advised Ms. Lydelle that he saw she didn't carrying in any food then Ms. Lydelle stated that she dropped off \$80 for food. Ms. Lydelle stated that she had to go to a couple of drug houses to find her mother. Ms. Lydelle stated that she does teaches English online for her job. Ms. Lydelle stated that Mr. Wadley was about to give her \$15,000 so she could get her own place and get back on her feet.

Officer Sampson concluded the interview with the fact that people are calling in and worried about her and that Officers aren't trying to get her in trouble for possession of drugs. Officers are only trying to get her out of an abusive relationship.

Officer Sampson spoke with Mr. Wadley. Mr. Wadley stated that they were strictly roommates and he is just trying to help her out. Mr. Wadley stated that she doesn't have a job and has battled drug addiction but doesn't think that she currently uses. Mr. Wadley stated that he paid for her to go to a suboxone clinic but she can never stay on the program. Mr. Wadley admitted to giving Ms. Lydelle money on regular basis

for food and what not but never drugs because he is against drugs. When asked about him getting stopped with the prostitute in the past Mr. Wadley had nothing to say. Mr. Wadley stated just he and Ms. Lydelle live at 1062 Oberlin Drive.

Mr. Wadley stated that he has taken her to the hospital multiple times for her injuries but she never stays and that she took off her cast while he was gone. Mr. Wadley stated he has never been abusive towards anyone and that Ms. Lydelle fell down the stairs while he was sleeping. Mr. Wadley stated that Ms. Lydelle doesn't have a vehicle or job, but she is allowed to go and do whatever she wants with her friends. Mr. Wadley also stated that lately he has been taking Ms. Lydelle to the Westside of Columbus to see her sick mother nearly every day. Mr. Wadley stated that Ms. Lydelle is currently married and has 4 kids that she sees occasionally. Ms. Lydelle's husband is also a drug addict and the kids live with the husband's parents. Mr. Wadley is married but has been separated for the past 6 years and that his wife lives in another state.

Officer Sampson informed Mr. Lydelle that he is enabling Ms. Lydelle's drug habit by giving her money and taking her to drug houses to see her "Mother". Mr. Wadley told Officer Sampson that he has told Ms. Lydelle that he can't keep giving her and her family money that she needs to go get a job and support herself.

Officer Sampson asked Mr. Wadley why he didn't answer the door for Officers when they were at his house the day prior. Mr. Wadley had no answer.

Training and experience would say that Ms. Lydelle is in an abusive drug addicted relationship with Mr. Wadley. Without witnesses or Ms. Lydelle having a change of heart, there is little Officers can do on this case.

The case is currently inactive.


