GENTLEMEN:-You have submitted an abstract certified by Jesse B. Axx, Abstracter, on October 3rd, and inquired as to the status of the title to the following described premises as disclosed by said abstract:

"Situated in the Township of Goshen, County of Tuscarawas and State of Ohio, and being lots 35 to 44 both inclusive, and lots 60 to 69 both inclusive, in J. C. Adair and C. A. Leach's sub-division of parts of lots numbers 7, 8 and 9 of the Schoenbrun tract known as the Schoenbrun allotment, saving and reserving a strip 140.5 feet off the east side of said lot number 60."

An examination of said abstract discloses the title to said premises to be in E. A. Myer, free from encumbrances, excepting as hereafter noted. The taxes for the year 1923 are a lien upon the premises; it further appears that Francis M. You have further submitted the deed executed by the said E. A. Myer and wife, which in my opinion is sufficient to convey the premises to the state when properly delivered.
