#### Narrative:

On September 9, 2023, Bureau of Criminal Investigation (BCI) Special Agent James Poole (SA Poole) received the attached incident reports from the Kroger security office. These documents were provided via email and attached to the case file electronically. These records were requested over email regarding the investigation of the Officer-Involved Critical Incident and the theft associated with Ta'kiya Young (Ta'kiya).

SA Poole reviewed the incident reports and the following should be noted:

- Kroger recorded a total of twelve (12) bottles of liquor that totaled \$701.82 that was stolen by the female suspects on 8/24/23.
- Ta'kiya was reported to have stolen eight (8) bottles totaling \$596.86
- Suspect #2 was reported to have stolen one (1) bottle totaling \$26.99
- Suspect #3 was reported to have stolen three (3) bottles totaling \$77.97
- Store notified time of theft 6:30PM
- Incident report created by Giebler Kroger Loss Prevention

#### **Case Narrative**

#### Case Report

At approximately 6:30pm, 3 female subjects left the West entrance of Columbus Store 965 with two of them possessing large handbag/purses. Upon exiting, the Electronic Article Surveillance (EAS) pedestals alerted. A store associate followed up and walked to the sidewalk to see the location of the subjects.

Status

Outcome

**Prosecuted** 

Blendon Township Police were on the parking lot assisting a customer who was locked out of their vehicle. Our associate made them aware of the situation. The 3 subjects entered two separate vehicles, a Black Lexus and a Black Chevrolet Cruze, both with no license plates displayed. The Black Lexus was parked in a handicap stall by the customer's car receiving assistance from the police. Police ordered the driver of the Black Lexus to get out of her vehicle multiple times. The driver of the Black Lexus did not comply and attempted to strike the standing officer with their vehicle. The officer fired one shot, striking the driver. The vehicle came to rest against the store front, near the Pickup/Pharmacy area. Police administered CPR and the subject was transported to St. Ann's Hospital, where she was declared deceased.

Per CCTV, the items stolen were State Liquor items by the three subjects; 12 bottles with an approximate retail value of \$701.82

Video and statements were provided to Law Enforcement. Blendon Township Police, Franklin County Sherriff, and Bureau of Criminal Investigations (BCI) were all on site.

Columbus VP of Operations, Melissa Stimac, District Manager Canon Anderson, Human Resource Leader Heather Gray, and Asset Protection Specialist Chris Trusler were on site following the incident.

Magellan Services were offered to associates.
