**Comments:** Case Synopsis: Imonie Hackett brandished and cycled a weapon in front of a nearby neighbor. Police were called to conduct a wellness check on Ms. Hackett. As police approached Ms. Hackett, she brandished a weapon. Officer retreated and set up a perimeter. After 19 hours of negotiations, OSHP SWAT moved on the apartment to rescue a 9 year old inside. As officers began the rescue, Ms. Hackett fired on Troopers, prompting the OSHP Sniper to fire on Ms. Hackett. Ms. Hackett was struck, administered first aid, and taken to a near by trauma center for treatment. She remains in the care of the Medical Center after surgery.

Analysis Request Details: Please test fire both firearms and compare recovered fired cartridge casings to the submitted firearm's.
