Narrative:

On September 3, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Nick Valente sent a preservation letter to Yeskamo through the email address listed on the company's website. On that same date, SA Valente called the telephone number listed on Yeskamo's website and did not receive a response. The voice mailbox prompt indicated that the phone number is not associated with the company or number dialed.

Yeskamo is a foreign company that produces Wi-Fi security cameras, monitors, and accessories. The company produced a security camera affixed to the front of the subject's home. SA Valente called the number listed on the company's website again on September 4, 2024, September 11, 2024, September 14, 2024, and January 2, 2025. SA Valente did not receive an answer on any of these occasions.

Note that the Yeskamo camera on the front of the subject's home was directed towards the front of the home, facing west, not to the right/north, where the subject was running at the time he was shot and therefore is not believed to have been directed in a way that would have allowed it to capture video of the subject as he was running and/or shot.
