## Narrative:

On Tuesday, August 02, 2022, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) John Butterworth (SA Butterworth) compiled background information on Pozz Striblin (Striblin), a subject involved in the incident on June 7, 2022. The information included researching past police reports involving the subject, searching criminal history records, court records (if applicable), open/closed-source database inquiries, and social media posts. The information gathered was obtained from the BCI Criminal Intelligence Unit, the Columbus Police Department, and Franklin County Sheriff's Office.

SA Butterworth reviewed the information and noted the following:

### Prior Police Encounters:

According to FCSO records provided, Striblin was listed as a suspect where two victims were shot and killed. The confidential investigative report lists the offense as murder for both the victims. The incident occurred May 31, 2022.

The Columbus Police Department provided a list of records where Striblin was listed as a victim, suspect or arrestee from their agency. The listed offenses and dates where Striblin was listed as a suspect or arrestee were the following: Theft from motor vehicle 12/30/2020 (Arrestee); FCCS Referral-SVB Detectives 11/05/2018 (Suspect); Miscellaneous Incident 10/31/2018 (Suspect); Motor Vehicle Theft 10/25/2018 (Suspect); Domestic Violence 9/04/2018 (Suspect); Assault 5/07/2018 (Suspect); Assault 9/14/2015 (Arrestee); Assault 5/20/2015 (Suspect); Assault 4/27/2015 (Arrestee); and Theft 7/02/2014 (Suspect). There are numerous reports where Striblin was listed as a witness or victim.
