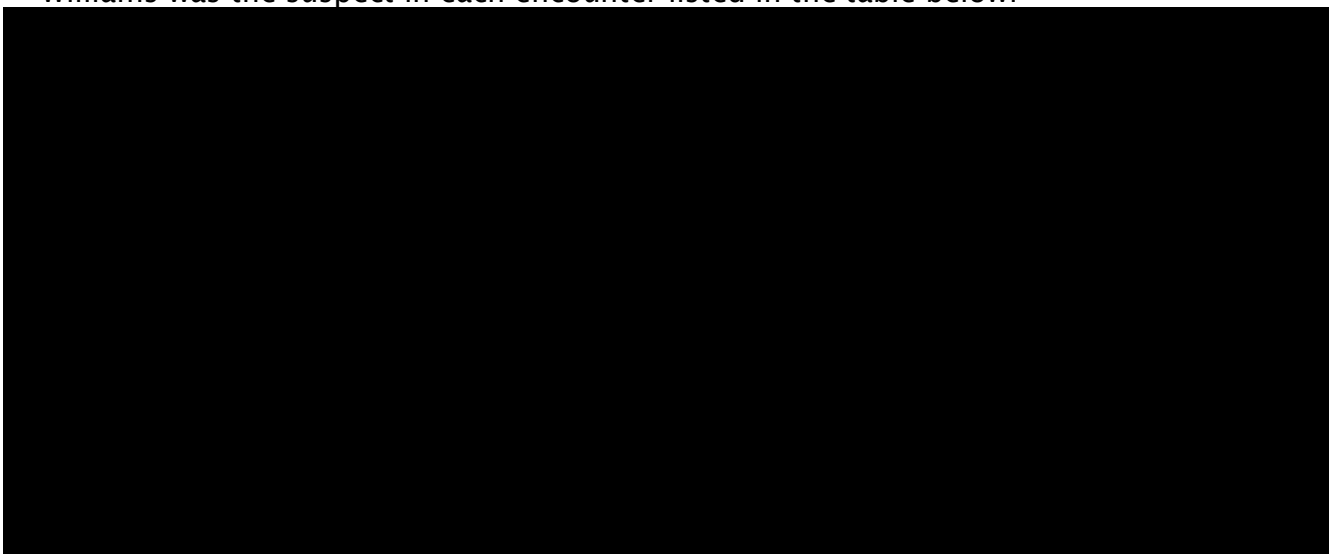
Narrative:

On Friday, April 04, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Joseph Goudy (Goudy) compiled background information on Shawn A. Ware (Ware), a subject involved in the incident on March 16, 2025. The information included researching past police reports involving the subject. The information was obtained from the Ravenna Police Department (RPD).

SA Goudy reviewed the information and noted the following:

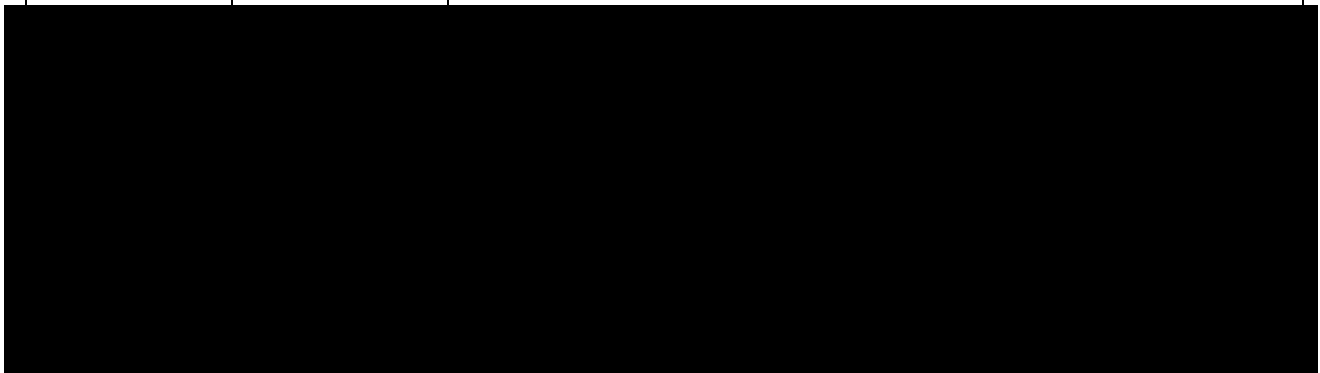
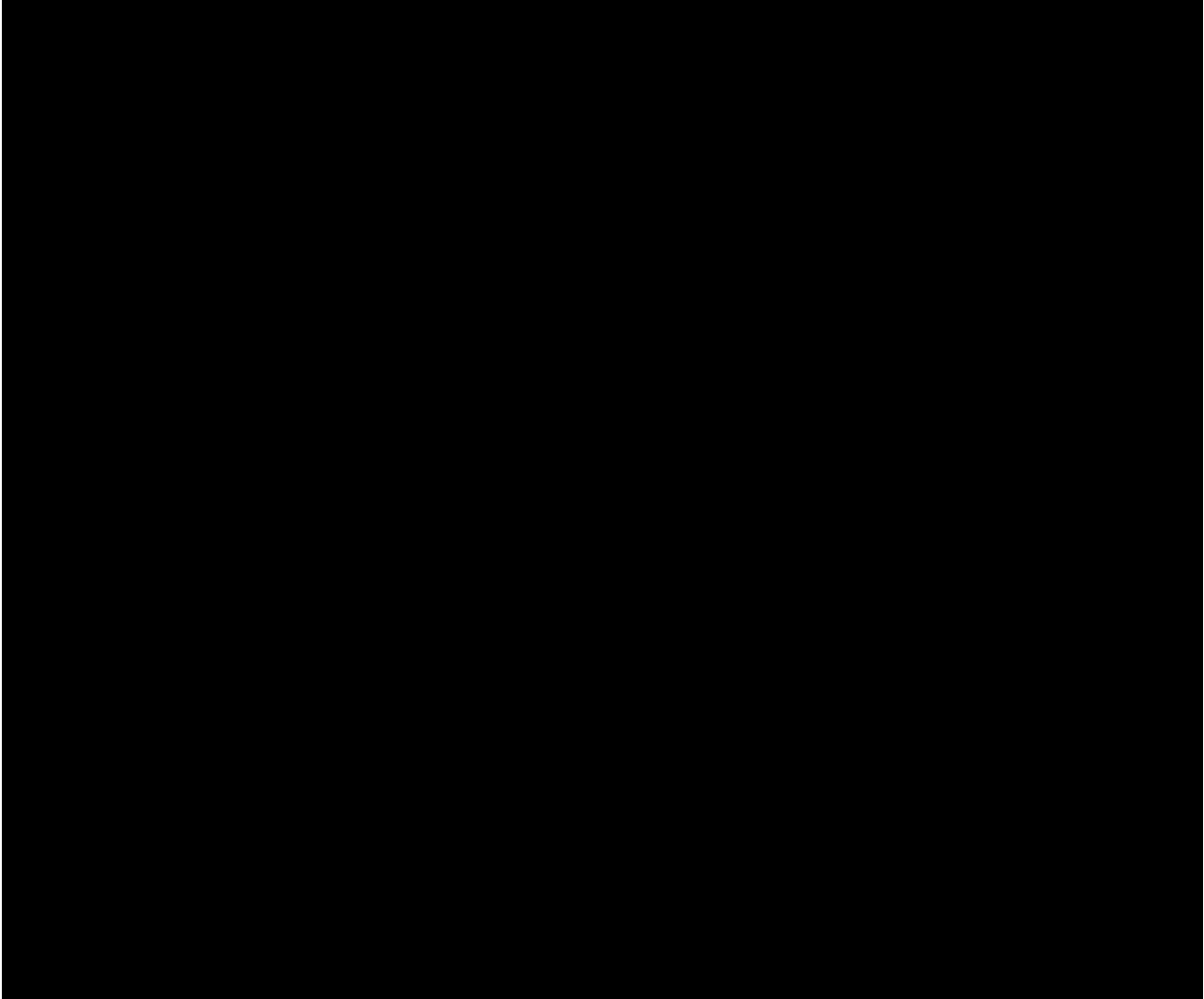

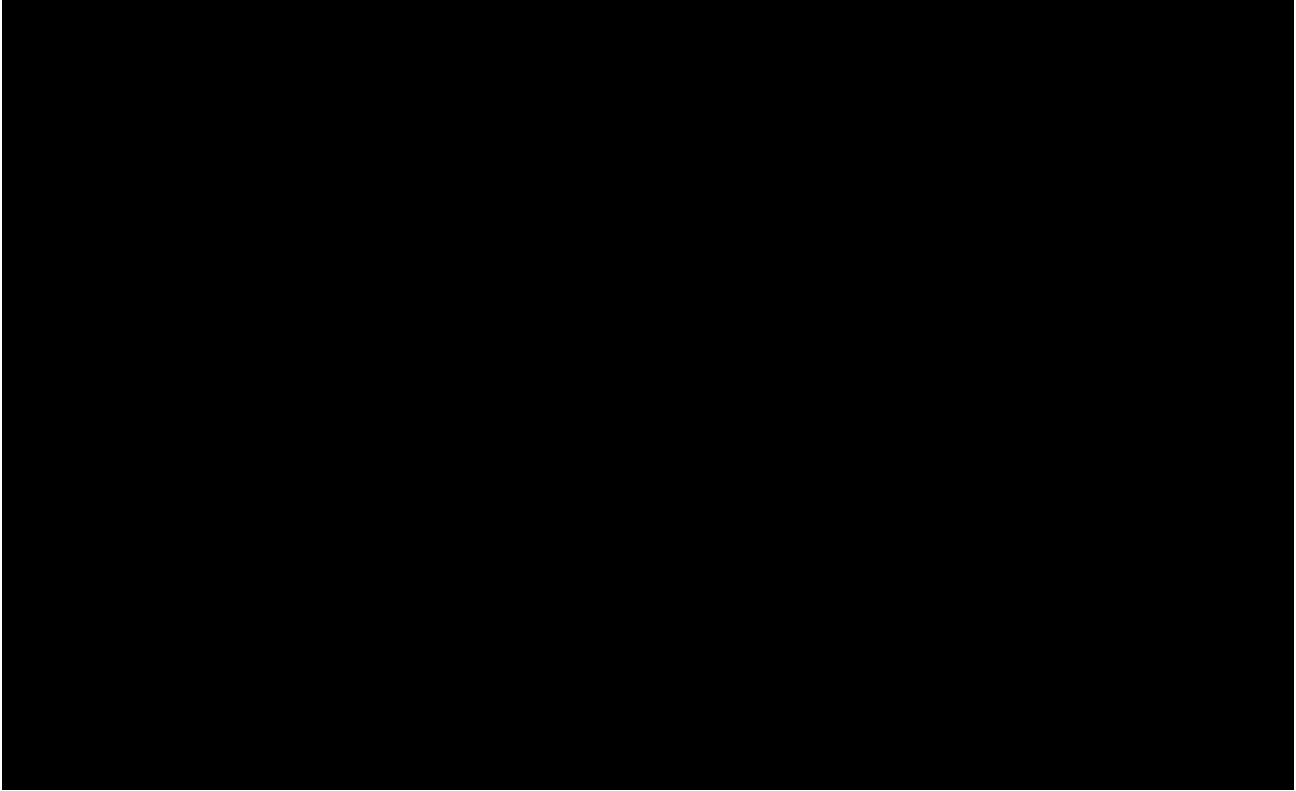

Supplement Title:

On 12-19-06 at approximately 1454 hours, I observed a purple Pontiac Bonneville traveling Southbound on Cleveland Rd. As the vehicle passed by, I observed it to have no front license plate and initiated a stop for the violation.

I approached the vehicle and made contact with the driver, Shawn A. Ware, and the front passenger, Frank White. I explained why they were being stopped and Ware said he was aware he did not have a front plate. He produced his license and when asked, they stated they were coming from Streetsboro and headed to McDonald's to get something to eat. White was unable to produce an ID, but recited his SSN. White stammered, making several errors in his SSN, but finally provided a complete SSN.

I returned to my police unit and checked the information through LEADS. Ptl. Cooper arrived on scene as I was advised the SSN White had provided, did not belong to him, but a male subject out of Columbus, Ohio. White was detained until a BMV image could be retrieved.

Ware stepped from the vehicle and gave me verbal consent to search his person and the vehicle. A search of his person uncovered:

From an outside coat pocket --
-- a plastic bag with marijuana totaling approximately 3.04 grams (tag #19014).

A search of the vehicle uncovered:

From the center console --
-- a blue marker, which concealed a pipe with burnt marijuana residue (tag #19014).

(located in the glove box: (2) 410 shotgun shells, (1) Corbon .45 round and (6) .38 special rounds

White's identity was confirmed with a BMV image and Ware was given a warning for the equipment violation and issued a summons for possession of drug paraphernalia.

Narrative Report

Officers responded to 330 Oakwood for a dispute between two males in the parking lot. The caller advised dispatch they thought they heard a gun shot as one of the males left the area in a blue Chevy car. As I approached the complex I observed the vehicle in question traveling north on Oakwood St. and then making a left turn onto Cleveland Rd.

I activated my lights and the driver, Shawn Ware, turned right onto Henderson and then left into the first driveway. Shawn was ordered out of his vehicle and then cuffed for Officer safety due to the allegations about the gun. Shawn stated he had been at the complex with his friend, Matt Lusane, when the two began to argue. Shawn claims the two were talking loud, but he denied yelling at each other. Shawn said after the disagreement was over he left. Shawn denied having a gun and stated we could check his car. After checking his car and confirming with Ptl.Holloway there had been no violence at the complex Shawn was released. Prior to leaving Shawn was warned for DOC.

I was dispatched to the listed address in regards to female subject, Felicite Shelton. When I arrived, I noticed Felicite laying on the floor unresponsive. RFD arrived and administered Narcan to Felicite. I spoke with witness, Shawn Ware, who stated he came down from his apartment and noticed Felicite sitting upright and all of a sudden fall over. I also spoke with PR, Davis Mosley, who stated Felicite came to his apartment from across the street with her laundry. Felicite began to fold her laundry when she fell over and started convulsing. David stated he called 911.

Once Felicite was administered Narcan, she awoke. Felicite stated she felt as if she had a seizure. She also stated she did not take any drugs. RFD believed Felicite was under the influence of a drug due to the Narcan effectively working. Felicite was transported to University Hospital where she will be treated accordingly.

I searched the laundry room where Felicite was apparently doing laundry for any type of drug paraphernalia and did not see anything.

Supplement Title: Initial

On 4/23/2023 at 2104 hours, I was dispatched to 668 Page St. for a complaint of multiple gun shots heard. Prior to arrival, I was flagged down by Michael Thompson. Michael advised he heard multiple gunshots coming from the parking lot of 668 Page St. He advised it sounded like automatic gun fire. He advised he observed a female sitting a black SUV in the corner of the parking lot and believes she may be involved.

Upon arrival, Ptl. Montes and myself approached the apartment complex with caution. At this time, dispatch advised they had received multiple other calls about gun shots in the area. Upon reaching the rear the parking lot, I could hear a female talking on her phone through her vehicle. I advised Ptl. Montes, to which we began our approach. At this time, Sgt. Coy arrived and we directed him to shine his spot light onto the vehicle with the female inside due to lighting in the parking lot. Upon contact, I announced myself as "police" and the female began exiting the vehicle. As I made contact with the female, Ptl. Montes advised there was a firearm in the back seat of the vehicle. I immediately detained the female in handcuffs and identified her as Marquita Sanders. I escorted Marquita away from the vehicle while Ptl. Montes secured the firearm.

I placed Marquita into the rear of P-6 and advised her of her Miranda Rights. She stated she understood her rights and asked if she was being arrested, to which I advised her she was only detained at this time for a pending investigation. When asked if she had fired any firearms today, she advised she had not but she did hear what may have been gunshots a few minutes prior to our arrival. She advised the located firearm was her cousin's and she was trying to sell it for him as he needed the money to pay rent. She admitted she was holding the firearm prior to our arrival, but continued to deny shooting it. After speaking with Marquita, I began searching the area around Marquita's vehicle for potential spent shell casings. I was unable to observe any casings in plain view around or in her vehicle, but I did observe 2 ammunition boxes on the rear floor of the vehicle. A CCH was pulled on Marquita which showed she was [REDACTED]

After consulting with Sgt. Coy about the situation, I asked Marquita for consent to search her vehicle. She was advised if consent was denied, we would be towing the vehicle and obtaining a search warrant for the vehicle. Marquita admitted there was marijuana in the vehicle causing her to initially be hesitant about giving consent, but eventually gave consent to search her vehicle.

I started searching the vehicle on the driver side, while Ptl. Wike began on the passenger side. Upon opening the driver's door, I observed a spent gold colored 9mm casing on the driver's seat. I then immediately confronted Marquita about my findings, to which she then admitted to shooting a few rounds into the ground. After returning to the vehicle, I located another spent casing on the ground outside of the driver's door. While securing the casing, Ptl. Wike advised he located numerous unknown pills and a bag containing psilocybin mushrooms. I then secured the ammunition boxes and continued my search of the vehicle. See Ptl. Wike's supplement for

additional findings in the vehicle.

After searching the interior of the vehicle, I began re-searching the surrounding area for spent casings. Officers then located multiple more spent casings near the front passenger side of the vehicle (approximately 7). I then spoke with Marquita some more about where and why she was shooting. She advised she was shooting "just because" and was not aiming at anyone or anything. She advised she thought she only shot 6 times but after being told 9 casings so far have been recovered, she admitted she probably shot more than 6 times. She was asked if anyone else was with her, to which she advised it was only her. She advised she was standing near the southeast corner of the parking lot and was shooting into the hill, towards the nearby railroad tracks. She advised there was 2 different types ammunition, some gold colored and some silver colored. I then returned to searching and advised the other officers of what Marquita had said. Officers then began locating numerous more spent casing (approximately 6) in the area Marquita advised she was shooting from. A total of 16 spent casings (some gold and some silver in color) were located and collected.

Marquita was transported on station by Ptl. Wike, while Sgt. Coy stood by waiting for John's Towing to arrive and take possession of Marquita's vehicle. Upon arrival, I had dispatch contact the PCSO to have them come and test the located narcotics at the request of Prosecutor Finnegan. Upon there arrival and testing, the 29 blue pills were found to be positive for fentanyl, the 11.67 grams of mushrooms were found to be positive for psilocybin mushrooms, and the white substance in the bill fold was found to be positive for cocaine.

Marquita was subsequently charged with 1 count of trafficking in drugs (F4) for the fentanyl pills, 1 count of trafficking in drugs (F4) for the psilocybin mushrooms, possession of drugs (F5) for the cocaine, and weapons under disability (F3) as she is a convicted felon.

Marquita was processed on station and transported to the justice center without incident.

The seized narcotics will be sent out to BCI for additional confirmation chemical testing.
