**Narrative:**

On Tuesday, November 26, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Jesse Bynum (SA Bynum) received video footage from the Medina County Sheriff's Office (MCSO). SA Bynum was informed that the videos contained footage from the drone, dash, and body cameras recorded by the Medina County Sheriff's Office.

SA Bynum reviewed the video recordings and noted the following:

The Medina County Sheriff's Office Drone video recordings are from two flights with each containing video in color and one in thermal. As both the thermal and the color video recordings have the same perspective, they will be shown together in the following review.

The files "DJI\_0893\_W" and "DJI\_0894\_T" were videos that were 11:58 in length and from a drone camera of Medina County Sheriff's Office. At the 00:30 mark of the video, Charles Alexander's left hand was observed holding a dark object being used to break the driver's side glass (Image 1, Image 3, and Image 4). The thermal view of the same point showed that there was a small object that penetrated the window at the same time that the glass was broken (Image 2).

At the 2:20 mark of the video Charles's left hand was observed holding a dark object consistent with the size and shape of a pistol pointing toward Oaklynn (Image 7). The thermal view was blocked due to the windshield (Image 8).



At the 49:57 mark of the video, Deputy McGurk was observed deploying the drone again. The body camera only showed the side of the cruiser. Nothing further of evidentiary value was noted.

(Percy) was heard advising other officers that Medina Township Police Chief John Minek (Minek) was on the phone with Charles Alexander as a crisis negotiator. At the 51:02 mark of the video, a gunshot was heard. Shortly thereafter, officers were observed running towards the location of the U-Haul. At the 54:13 mark of the video, Life Support Team's (LST) ambulance was observed traveling through the Arby's parking lot towards the U-Haul (Image 22). Nothing further of evidentiary value was noted.

At the 05:22 mark of the video, Deputy Cotrufo was heard discussing a plan to use a hill nearby for cover to shoot Charles Alexander. It was decided, due to the location of Charles, Oaklynn, and other officers, there were limited angles. Nothing further of evidentiary value was noted.

The file "GabrielCotrufo\_202411112036\_BWC2023868-0" was a video that was 27:37 in length and from Medina County Sheriff's Office body camera worn by Deputy Gabriel Cotrufo. In the upper right corner of the video is a time and date of 11/11/2024 20:36:01 along with an identifier of BWC2-023868. Audio is not present until the 0:05 mark of the video. At the 00:00 mark of the video, Deputy Cotrufo was observed in the parking lot of Bob Evan's near the North side (Image 26).

**ADDITIONAL FACTORS FOR EVALUATING THE VIDEO RECORDINGS**

There are numerous other factors that need to be considered when reviewing and evaluating the videos and audio recordings of this incident. Those factors are:

**A.** Video recording devices record within the video and sound capabilities available, and they record objectively. Video recordings lack the history, perspective, and interest of the people involved. The positions, angles, obstacles, lighting, and distance from the incident are also factors that need serious consideration.

**B.** Video recording devices also record more information about a particular scene or incident than the person(s) involved in the incident can process during the critical incident. Video recording devices rarely record an event from the same perspective of the officer. It captures the action but not the perception, decision making, focus, or intent of the officer. Video recordings often miss tactile cues or other actions of a subject.

**C.** The speed of the incident is remarkable. The speed and complexity of rapidly evolving situation(s) that occur during use of force encounters are difficult concepts to comprehend by only watching the video.

The video footage was submitted to the physical BCI case file as item Reference Item C - Aviation\_Drone\_Dash\_and\_Body\_Camera\_Video for reference only.


