Narrative:

On Wednesday, April 15, 2026, at 0948hrs, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) David Hammond received twenty-two (22) items of evidence from Evidence Intake Technician Abbe Harshbarger in regard to the Tuesday, February 24, 2026, Parma Police Department officer involved critical incident (Figure 1, Evidence Release Receipt). The items of evidence were subsequently placed into permanent evidence by Administrative Professional Betsy Turney at 1059 hrs.

It should be noted that during laboratory testing, additional items of evidence were retained as part of any analysis. Lab items 12.6, 13.1, and 14.1 are contained within the original item of evidence.
