Narrative:

On July 5, 2022, Bureau of Criminal Investigation (BCI) Special Agent (SA) Jon Lieber (Lieber) requested records related to a fatal crash involving Jaymeisha Beasley (Beasley). On July 5 and 6, 2022, SA Lieber received responsive records to the request. A review of those records revealed the following:

Crash #83-0445-83 (2022) – This PDF file consists of 26 pages. The date and time of the crash is listed as 05/28/2022, at 01:18 AM. This report relates to the initial crash of a Sewell semitruck rear-ending a Ford Econoline van. During this crash, the van's right rear passenger, Jaymeisha Beasley, was ejected from the van and thrown into the roadway.

Crash #83-0446-83 (2022) – This PDF file consists of 12 pages. The date and time of the crash is listed as 05/28/2022, at 01:18 AM. This report relates to the second crash involving a hit skip of an ejected passenger (Jaymeisha Beasley) from the crash noted above. Beasley died as a result of her injuries.

83-0446-83 – This file contains 276 photographs of the roadway and tire marks at the crash scene

83-0446-83-KBXSC8T – This file contains 178 photographs of the van and semi-truck involved in the crash.

83-0446-83-PHPBEGP – This file contains 19 photographs of the interior of the semi-truck.

The crash reports have been attached to this report. The files containing the photographs have been copied onto a DVD disc and placed in the physical case file as item E.

Two additional Ohio State Highway Patrol (OSHP) reports (22-042008-0883 and 22-920019-0300) were received, however, OSHP stated that these reports were "Pending" and therefore not for public disclosure. SA Lieber will follow up with OSHP at a later date to determine if the reports are no longer in Pending status.

SA Lieber followed up on the above referenced reports on multiple occasions. Most recently, on January 24, 2023, SA Lieber received a response from Christian Pruitt (Pruitt) in the Central


