**Narrative:**

On Monday, April 19, 2021, the Bureau of Criminal Investigation (BCI) Special Agent Supervisor (SAS) Kevin Barbeau sent a subpoena, via fax, to Westerville Division of Fire (WFD), attention Chief Mindy Gabriel. The purpose of the subpoena is to obtain records pertaining to Miles Jackson, who was transported to St. Ann's Hospital (500 South Cleveland Ave, Westerville, Ohio) on Monday, April 12, 2021. Jackson was later involved in an Officer-Involved Critical Incident (OICI), which occurred at St. Ann's Hospital on this date. BCI learned Columbus Police Officers were taking Jackson (involved subject) into custody at St. Ann's Hospital Emergency Department (ED). A struggle ensued and CPD Officers and St. Ann's (armed) Security Officers discharged their duty weapons. Miles died from apparent gunshot wounds.

On the same date. SAS Barbeau received the attached WFD EMS run report. Upon reviewing the report the following is noted:

- Incident location: Chase Bank; 380 S. Cleveland Ave., Westerville, Ohio 43081
- Dispatch Notified/Call Received: 11:27:38; Dispatched: 11:28:22
- Enroute: 11:30:12; On Scene: 11:32:27; At Patient: 11:33:00
- Depart Scene: 11:46:40; At Destination (St. Ann's) 11:56:29; Patient Transferred: 11:58:00
- Patient Information is listed as "Jackson Williams;" it was believed Miles had given EMS and Westerville Division of Police (WPD) a false name
- Date of Birth is listed as December 5, 1993, which is consistent of Miles' actual date of birth.
- Chief Complaint: Lethargic; Signs & Symptoms: Drowsiness and Altered mental state
- Mental Status: Confused to location and moth/day' lethargic and falling asleep during assessment
- Narrative notes the patient admits to taking Percocet; but did not provide dose; pupils are fixed and non-reactive; administered 1mg of Narcan prior to arrival to St. Ann's

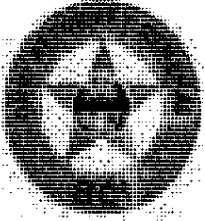
