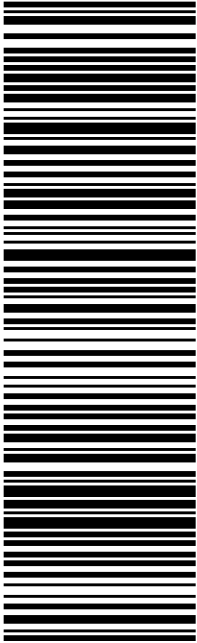

The Special Prosecutions Section of the Ohio Attorney General's Office was appointed as special prosecutor pertaining to above-referenced matter. The Cuyahoga County Grand Jury will be meeting in the coming weeks to review the facts surrounding the shooting death of your son, Christian Thomas, which took place on August 30, 2024.

Grand Jury proceedings are not open to the public and therefore, no family members or observers can be present in the hearing room. Court rules prevent us from disclosing the exact date when the Grand Jury will hear this case. However, once a decision has been reached by the Grand Jury, we will notify you as soon as possible.

If you or a member of the family wishes to provide information to be presented to the Grand Jury, or if you have knowledge of a witness who has not been interviewed by the police and has relevant information, please contact me at 614-284-4951.
