There has also been submitted the certificate of the Superintendent of Insurance, relating to the qualification of the Bonding Company, the certificate of the Industrial Commission, as required under section 2319 G. C., proof of the publication of the necessary advertisement and the tabulation of the bids, proceedings of the board of trustees authorizing the Department of Highways to enter into such contracts, and the certificate of the Director of Highways showing that proper plans were prepared and submitted and approved by the Highway Department, as the successor to the Building Commission.

GENTLEMEN :- You have submitted to this department for approval, a contract between the State of Ohio, acting by the Battle Flag Committee consisting of the Governor, Auditor of State, and Adjutant General as created by the General Assembly in an act found in 109 O. L. 545, and The John Harsh Bronze and Foundry Company of Cleveland, an Ohio corporation. This contract is for the erection and completion of flag cases for the World War flags and calls for the expenditure of \$11,950.00. You have further submitted a certificate of the Director of Finance to the effect that there are unencumbered balances legally appropriated to cover the amount designated in the contract. Accompanying said contract is a proper bond to insure faithful performance upon which the Republic Casualty Company of Pittsburgh is surety. There has been submitted sufficient evidence as to the qualifications of said surety company to do business in Ohio. Evidence has been submitted showing that the plans for the proposed work were approved by the Battle Flag Committee, and the certificate of the Industrial Commission as required by section 2319 G. C. has been presented. You have further submitted evidence to the effect that the Controlling Board waived the provisions of section 6 of H. B. 301 relative to the requirements of advertising, etc. However, it appears that notwithstanding the action of said board, you did obtain competitive bids, which were tabulated and the lowest bid was accepted.

Inasmuch as the contract and bond are in proper legal form and the other proceedings relating thereto are in all respects legal, I have this day noted my approval thereon and return the same to you herewith, together with all other data submitted in connection with the matter.
