Narrative:

On July 11, 2023 at approximately 2300 hours Ohio Bureau of Criminal Identification and Investigation (BCI) Special Agents Ryan Scheiderer and Brady Curry (SA Scheiderer and SA Curry) conducted a neighborhood canvass in the area of 114 N. 9th Street, Byesville, Ohio (Guernsey County) in reference to a shooting incident between Jerimiah Wise (Wise) and law enforcement. Wise was fatally shot by law enforcement during the incident. The following is a summation of the contacts SA Scheiderer had with neighbors in the area. SA Curry will document his contacts separately.

118 N. 9th Street:	Lyndon Murray ([REDACTED]) stated he was home the entire time, but only saw law enforcement in the street. Didn't witness the shooting, but did hear what he believed was five (5) gunshots
116 N. 9th Street:	Julie Christman (See IR-2 2023-07-11 Contact with Julie Christman and Henry 'Michael' Shaffer)
120 N. 9th Street:	Henry 'Michael' Shaffer (See IR-2 2023-07-11 Contact with Julie Christman and Henry 'Michael' Shaffer)
124 N 9th Street:	No answer

113 N. 9th Street:	Carlene Voytko ([REDACTED]) stated she didn't know anything was happening until she heard gunshots. Looked out the window and saw law enforcement entering Wise's residence.
111 N. 9th Street:	Marjorie Province ([REDACTED]) stated she saw law enforcement activity near the intersection. Saw an officer with a rifle. Heard gunshots, but didn't know who shot and believed one came her front yard. Felt law enforcement was very patient with Wise.
108 N. 10th Street:	No answer
