Narrative:

On Tuesday, December 17, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) John Tingley (SA Tingley) compiled background information on Tyler Jacobs (Jacobs), a subject involved in the incident on December 7, 2024. The information included researching past police reports involving the subject, searching criminal history records, court records (if applicable), open/closed-source database inquiries, and social media posts. The information gathered was obtained from the BCI Criminal Intelligence Unit and the Shelby Police Department (SPD).

SA Tingley reviewed the information and noted the following:


