### Narrative:

On Thursday, April 15, 2021, the Bureau of Criminal Investigation (BCI) Special Agent Supervisor (SAS) Kevin Barbeau received Westerville Division of Police (WPD) report 2021–9399. This report was completed by WPD following an Officer–Involved Critical Incident (OICI) which occurred at St. Ann's Hospital (500 South Cleveland Ave, Westerville, Ohio) on Monday, April 12, 2021. It was learned Columbus Police Officers were taking Miles Jackson into custody at St. Ann's Hospital Emergency Department (ED) room. A struggle ensued and CPD officers and St. Ann's (armed) Security Officers discharged their duty weapons. Miles died from apparent gunshot wounds.

SAS Barbeau reviewed the attached WPD Death Investigation report. The following was provided:

"Miles Jackson was killed after exchanging gunfire with Columbus Police and St. Ann's Hospital Security.

On 4/12/2021, the Westerville Police responded to Mount Carmel St. Ann's Hospital ER department on the report of an officer in trouble. There was a report of an unknown type of altercation with a combative patient.

While officers were en route to St. Ann's, Dispatch advised that St. Ann's security officers reported hearing gunshots inside the ER and at least one security officer marked on the radio "10-3." Dispatch also advised that a Columbus Police Officer was being held inside a

room by a subject, later identified as Miles Jackson. A short time later Dispatch advised that per CPD, shots had been fired and the Jackson was down.

Upon arrival, several Westerville Police officers immediately entered the ER to secure the scene. Jackson was handcuffed and transferred to a hospital bed. Jackson was transported to a trauma bay to be treated for gunshot wounds. Officers established scene security and began separating witnesses.

Jackson succumbed to his injuries and died. There were no injuries to any St. Ann's Hospital staff, Columbus Police, or Westerville Police.

### **OfficerID: WESTERVILLE\Muellerb, Original Narrative**

Miles Jackson was killed after exchanging gunfire with Columbus Police and St. Ann's Hospital Security.

On 4/12/2021, the Westerville Police responded to Mount Carmel St. Ann's Hospital ER department on the report of an officer in trouble. There was a report of an unknown type of altercation with a combative patient.

While officers were en route to St. Ann's, Disptach advised that St. Ann's security officers reported hearing gunshots inside the ER and at least one security officer marked on the radio "10-3.". Dispatch also advised that a Columbus Police Officer was being held inside a room by a subject, later identified as Miles Jackson. A short time later Dispatch advised that per CPD, shots had been fired and the Jackson was down.

Upon arrival, several Westerville Police officers immediately entered the ER to secure the scene. Jackson was handcuffed and transferred to a hospital bed. Jackson was transported to a trauma bay to be treated for gunshot wounds. Officers established scene security and began separating witnesses.

Jackson succumbed to his injuries and died. There were no injuries to any St. Ann's Hospital staff, Columbus Police, or Westerville Police.

The Ohio Bureau of Criminal Investigation agents arrived and established custody of the scene. BCI well be conducting the investigation of this incident.
