**Narrative:**

On Monday, February 03, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent Andrew Harasimchuk began a review of Akron Police Department (APD) Officer Michael Shaffer (Officer Shaffer) and APD Officer Dylan Ostrander's (Officer Ostrander) dash camera footage for this case. BCI SA Jonathan Lieber had requested that SA Harasimchuk use Amped Replay to conduct a review of the dash camera footage immediately surrounding the officer-involved critical incident. The officer-involved critical incident occurred on November 28, 2024, at 1055 East Avenue, Akron, Ohio 44307.

SA Harasimchuk located Officer Shaffer and Officer Ostrander's dash camera video file on the SIU shared drive for this case. The file was labeled as follows:

- **In-car camera - Ofc. Ostrander and Ofc. Shaffer**

SA Harasimchuk made a working copy of this video and placed the copied video in a folder on his BCI issued laptop. The working copy was used for the review.

**In-car camera - Ofc. Ostrander and Ofc. Shaffer**

- The video-embedded timestamp date was 2024-11-28.
- The video-embedded timestamp start time was 23:00:31 hours (frame 0).
- The video-embedded timestamp end time was 23:16:56 hours (frame 29561).
- The video file was from an Axon brand dash camera.
- The length of this video file was 00:16:25:366.

It should be noted that there was no audio for approximately the first 29 seconds of the video file and that the dash camera footage did not capture any portion of the officer-involved shooting.

The report was exported to the "Report" folder and the booked marked images were exported to the "Demonstratives" folder.

Additionally, Amped Replay was used to create a second demonstrative product removing the previously mentioned bookmarks and using the annotate spotlight feature and having the video playback at rate of 10 frames per second. An Amped Replay report was generated for the video review. The report was exported to the "Report" folder and the video was exported to the "Demonstratives" folder.
