**Narrative:**

On Friday, September 20, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Aja Chung (SA Chung) received video footage from Detective Jason Meadows from the Fairfield County Sheriff's Office (FCSO). SA Chung was informed that the fourteen (14) videos contained footage from the various jail cameras recorded by the FCSO from within the Fairfield County Jail facility. The videos were electronically saved in the BCI Shared drive in folder: 2024-2738 – Fairfield SO – OICI.

Chad Evangelista (Evangelista) was arrested by the Fairfield County Sheriff's Office on September 7, 2024, for disorderly conduct and obstructing official business and transported to the Fairfield County Jail. At the time of Evangelista's arrest, he was wearing a black T-shirt, dark colored shorts and tennis shoes. He can be described as a White male, six feet and one inch tall (6'1") with short brown hair.

SA Chung reviewed the video recordings and noted the following:

**C044 - VEHICLE SALLYPORT B151\_20240907\_164500.mp4**

- The footage was two (2) minutes and twenty-one (:21) seconds long, contained no audio and provided a camera angle inside the sallyport.
- There were two (2) Fairfield deputies, recognized to SA Chung through her investigation. [REDACTED], the arresting deputy and corrections officer, (CO) Kunkler (CO Kunkler).
- The footage captured CO Kunkler, and a male deputy use a pulling motion to remove a subject from the cruiser. The subject can be identified as Evangelista.
- After two (2) minutes into the footage, nothing remarkable occurred.

**C043 - CORRIDOR B149\_20240907\_164500.mp4**

- The footage was one (1) minute and seventeen (:17) seconds long and provided a camera angle of doors B150 and B147.
- Thirty-nine (39) seconds into the video, Evangelista, in handcuffs, was observed to be flanked by CO Kunkler, positioned on Evangelista's right side, and the assisting jail deputy on Evangelista's left side.
- CO Kunkler was seen underhooking his left arm under Evangelista's right arm with his hand on Evangelista's right shoulder.
- The assisting jail deputy/CO was seen underhooking his right arm under Evangelista's left arm with his right hand placed on Evangelista's left shoulder.
- Nothing of investigative value occurred after the fifty (50) second mark.

**C042 - VESTIBULE B147\_20240907\_164500.mp4**

- The footage was forty-five (:45) seconds long, provided a camera angle of a hallway that contained doors labeled B148, B146B and B134, and B142.
- Twenty (20) seconds into the footage, Evangelista, in handcuffs was observed being escorted down the hallway in the same manner as described above, and into jail cell B142 by CO Kunkler, one (1) assisting male jail deputy/CO and [REDACTED]
- As the jail cell door was opened, Evangelista was observed to plant his feet and lean backwards into the deputies.
- Once inside the jail cell, [REDACTED] was seen closing the door and walking out of the camera's view.
- The footage ended when [REDACTED] was observed carrying items and opening door B134.



**C040 - PRE-BOOKING B142\_20240907\_165000.mp4**

- The video was 6:35:33 long and provided a view of jail cell doors labeled B142, B146A and B145. There was no audio to the footage.
- Eleven (11) minutes and ten (:10) seconds into the footage, Evangelista entered into the pre-booking area through door B142 being escorted in the same aforementioned description by [REDACTED] CO Kunkler and one (1) deputy/CO.
- Evangelista was observed with his hands behind his back in handcuffs and he was flanked by CO Kunkler and an assisting jail deputy/CO. [REDACTED] was seen walking behind Evangelista.

- Deputies were observed attempting to have Evangelista sit in a chair, however Evangelista was seen using his body weight to counteract sitting down.

- Evangelista was then placed into pre-booking jail cell door B146A. Evangelista could be seen using his feet to push, using his body weight to counteract the deputies escorting Evangelista.
- While inside the jail cell, deputies were observed to make continued attempts to get Evangelista to sit down as Evangelista was seen counteracting deputies actions.
- Part of the view was blocked by the wall when deputies moved to the other wall inside the jail cell. Only [REDACTED] could be observed.
- Thirteen (13) minutes and twenty (:20) seconds into the footage, Evangelista and deputies were observed to go to the ground. Evangelista could not be seen after he was on the ground.
- Fifteen (15) minutes and forty-six (:46) seconds into the footage, all three (3) deputies exited the jail cell. [REDACTED] being the last one to exit.
- Evangelista could be seen getting up from the floor, walk to the window and could be seen moving his mouth.
- For approximately five (5) and one-half (30) hours, Evangelista was observed to be constantly moving, fidgeting with his hands and talking. There were times Evangelista would knock on the window, and drink water from a source behind the half wall. At one point Evangelista used his shoe to beat on the cell window, door and something in the corner of the cell.
- Jail personnel would intermittently speak to Evangelista during those five and one-half hours.
- 5:26:53 hours into the footage, a female deputy with [REDACTED] spoke to Evangelista through the window and pointed downward. Evangelista's legs and feet were observed on the half wall inside the jail cell.
- 5:27:08 hours into the footage, that same female deputy removed OC spray from her duty belt, entered the jail cell and aim the OC spray towards Evangelista's face.



- CO Kunkler was seen entering the jail cell, walked behind Evangelista and grabbed onto Evangelista's arms. CO Kunkler could be seen releasing his hold of Evangelista at the same time the female deputy was seen aiming the OC spray towards Evangelista.
- The female deputy was observed to grab Evangelista's left arm as Evangelista was seen walking out of the jail cell.



- Evangelista was observed attempting to exit door B142 as CO Kunkler wrapped his arms around Evangelista's waist, picked Evangelista up and attempted to place Evangelista back into the jail cell.



- Simultaneously, Evangelista was seen grabbing on to the door B146A with his right hand and shut it as CO Kunkler took Evangelista to the floor.



- Three (3) deputies were observed attempting to get Evangelista detained. The female deputy was seen applying handcuffs to Evangelista's right wrist as the other two (2) deputies attempted to hold Evangelista still on the floor.
- A male deputy was seen leaving the area, and Evangelista can be observed moving his shoulders as CO Kunkler maintained control of Evangelista's upper body as the female deputy was seen controlling Evangelista's legs.
- A male deputy returned with a gray restraint chair and was seen taking control of Evangelista's legs as Evangelista kept moving his legs. CO Kunkler can be observed regurgitating into a trash can.
- Deputies stood Evangelista up and guided Evangelista backwards towards the restraint chair. Evangelista could be seen counteracting the deputies guiding movements, by leaning forward, away from the restraint chair. Two (2) sets of handcuffs were observed to be applied.

- Due to the camera's angle, Evangelista's and jail deputies' actions were not captured once Evangelista was placed in the restraint chair.
- Individually, each deputy came into the camera's view. CO Kunkler was observed to be regurgitating again into the trash can.
- 5:36:00 hours into the footage, Evangelista was observed to be restrained in the chair as deputies attempted to apply or secure the shoulder straps.
- CO Kunkler was seen using both hands to grab under Evangelista chin. Evangelista's face was observed to be wet.



- Once Evangelista's shoulders were secured, the female deputy and another male jail deputy were seen to bend down near Evangelista's left foot. The male deputy was seen saying something to Evangelista.
- 5:37:36 hours into the footage, the female deputy could be seen striking Evangelista's left leg multiple times with a right-hand closed fist. Evangelista was still observed to have labored breathing.





- 5:39:22 hours into the footage, Evangelista was wheeled out of the pre-booking area. Evangelista could be seen in the restraint chair with shoulder, waist and ankle straps, with his hands restrained in handcuffs behind his back.
- Nothing remarkable occurred after the 5:40:00 hour mark.

- The footage is 6:25:40 hours long, contains no audio and provides a stationary camera view inside a jail cell.
- 11:09 minutes into the footage, the lower halves of three (3) jail personnel come into view along with a subject wearing shorts and one tennis shoe outside of the jail cell.
- The jail cell door opened, and Evangelista was observed being escorted into the cell by [REDACTED] CO Kunkler, and another male deputy.
- Evangelista was observed planting his feet on the floor using his body weight to push backwards and into deputies as they walked further into the jail cell. At one-point deputies were observed to bend over, place their hands around Evangelista's ankles to lift Evangelista's feet off the floor.
- Evangelista was observed talking and moving his body in the opposite direction the deputies were attempting to guide Evangelista. Evangelista could be seen posting his right leg on the concrete bench just before Evangelista was taken to the floor and out of the camera's view.
- Fifteen (15) minutes and thirty-two (:32) seconds into the footage, each of the escorting deputies were observed walking to the jail cell door one at a time and eventually exit the jail cell.
- Evangelista was seen getting up from the floor, look out the cell door, and talk to the camera positioned on the cell ceiling.
- For the next five (5) hours and fifteen (15) minutes, Evangelista was seen trying to open the cell door near the lock, knocking on the windows, at times hit the ceiling camera with his shoe, and was never observed to stop moving.
- 5:26:45 hours into the footage, a female deputy with [REDACTED] was seen outside the jail window talking and pointing downward. Evangelista could not be seen. Within seconds, Evangelista's shoe and hand were seen near the jail cell ceiling camera.



- The female deputy was seen removing her OC spray canister from her duty belt and present/show it to Evangelista. Evangelista did not comply with orders that were seen being given through the window.
- 5:28:06 into the footage, the female deputy entered the jail cell, aimed and deployed OC spray towards Evangelista. Evangelista was seen putting his left arm up and turning his face away from the OC stream.

- CO Kunkler was seen grabbing Evangelista's shoulders and suddenly disengaging. The female deputy grabbed Evangelista's left arm as Evangelista started to walk out of the jail cell.
- Once Evangelista was outside the jail cell, CO Kunkler was seen running after Evangelista, wrap his arms around Evangelista's waist and lift Evangelista up.



- CO Kunkler, still carrying Evangelista by his waist, was observed carrying Evangelista back towards the jail cell. Evangelista was seen closing the cell door.
- Still outside the jail cell, CO Kunkler and Evangelista were seen falling backwards onto the floor and out of the camera's view.

- 5:30:27 hours into the footage, a female deputy with [REDACTED] was observed controlling Evangelista's feet. At that same time, a gray restraint chair was observed.
- A male deputy/CO was observed to stand up from a kneeling position and seconds later Evangelista was observed to be in handcuffs as he was guided and placed the restraint chair.

- Evangelista was seen counteracting the deputies/COs control by leaning forwards, kicking his legs after one deputy/CO was observed grabbing Evangelista's right ankle. Due to the camera angle, only Evangelista's legs were observed after he was placed in the restraint chair.
- A female deputy could be seen at Evangelista's feet trying to secure Evangelista's ankles with straps. Evangelista could be seen moving his feet away and out from the ankle straps.

- 5:36:53 hours into the footage, Evangelista was observed to be secured in the restraint chair with his ankles in straps and his hands were behind his back.

- 6:05:17 hours into the footage, a female deputy entered the jail cell with an inmate dressed in orange and white striped jail attire and pointed to part of the wall. Inmates were seen cleaning the floor and an area on the wall where the female deputy pointed to.
- Nothing remarkable occurred after the 6:09:00 hour mark.

**Export\_20240907\_221841.mp4**

- The video was fourteen (14) minutes and twelve (:12) seconds long and provided a stationary camera view of door B158. This video was the only footage that contained audio.
- A male deputy was observed retrieving a gray restraint chair from behind door B158.
- A male yelling in the background could be heard.
- Ten (10) minutes into the footage, a door opening, people talking and a male voice yelling, "No!" was heard and observed.
- One (1) female deputy with [REDACTED] and two (2) male deputies were observed entering the room and opened the door labeled B161.
- The same male voice that was heard yelling, "No" could be heard saying, "Chad Evangelista."
- Eleven (11) minutes and eight (8) seconds into the footage, a female voice was heard saying, "(inaudible) get this all off your face." Evangelista was heard yelling, "No."
- Running water was heard as Evangelista continued to yell, "No!", "Help!", "Leave me alone."
- Twelve (12) minutes and thirty-eight (:38) seconds into the footage, a male deputy was observed walking backwards from the door B161. Evangelista can be heard yelling, "NO!" continually as deputies were seen adjusting the restraint chair and heard trying to calm Evangelista down.

- A male deputy can be seen grabbing underneath Evangelista's jaw with both of his hands and securing the back of Evangelista's head against the chair backing. Evangelista's face could be seen at that time.
- Evangelista was wheeled out of the room and out of view.
- Evangelista was heard yelling, "My name is Chad Evangelista. My mother is Vanessa Chin (inaudible)".
- The footage ends as Evangelista could be heard talking.

**B157\_20240907\_221954.mp4**

- The video was 3:56 minutes long and contained similar footage as the above video (Export\_20240907\_221841.mp4) but contained no audio. The footage provided a stationary camera view of door B158.
- Male deputy observed retrieving gray restraint chair from behind door B158.
- Deputies are observed entering into a cell and minutes later exiting the same cell with Evangelista in a restraint chair. Evangelista's face could be observed three (3) minutes and seventeen (:17) seconds into the footage.
- A male deputy can be seen grabbing underneath Evangelista's jaw with both of his hands and securing the back of Evangelista's head against the chair backing. At that same moment, a female deputy can be seen pulling/tightening straps behind the back of the chair.
- As Evangelista was removed from the cell, Evangelista was observed to be secured in the chair with shoulder straps and his hands behind his back. Evangelista appeared to be breathing heavy, eyes open and was looking around. His mouth appeared to be moving as well.
- Deputies wheeled Evangelista out of view. Nothing of investigatory value occurred after the three (3) minute and forty (:40) second mark.

**C041 - TRANSFER B141\_20240907\_213000.mp4**

- The footage was three (3) minutes and forty (40) seconds long and contained no audio. The camera angle provided a view of doors labeled: B144, B143 and B141B.

- Three (3) minutes into the footage, Evangelista was observed to be secured in the restraint chair and being wheeled from the area.
- Nothing of investigative value was observed after the three (3) minutes and fifteen (:15) second mark.

**C037 - INTAKE BOOKING SOUTH B134\_20240907\_221000.mp4**

- The video is thirty-five (35) and one-half (:30) minutes long and provided an overhead view of a common area within the jail. The footage resembled a fishbowl, where the bottom of the camera is upside down. The central monitoring area could be seen at the six (6) o'clock position.
- Two (2) inmates wearing orange and white jail clothing were observed and another subject was seen sitting in a chair at the nine (9) o'clock position.
- Six (6) minutes and thirty-nine (39) seconds into the footage, two (2) deputies could be seen walking from the central monitoring area into a jail cell located at the one (1) o'clock position in the camera's view.
- Between the minute marks of 8:02 and 8:12, two (2) deputies were observed running towards the jail cell.
- Eight (8) minutes and fifteen (15) seconds into the footage, deputies are seen moving on the floor. The inmate sitting in the common area was observed to get up and look in the direction of the altercation.
- Near the jail cell door where the altercation took place, one (1) deputy was observed on their knees as another deputy was seen bent over.
- Nine (9) minutes and fifty (50) seconds into the footage, one (1) deputy was observed exiting the jail cell and walking towards the central monitoring area out of view.
- Ten (10) minutes and twenty-six (26) seconds into the footage, one (1) deputy wheeled a gray restraint chair to the jail cell where deputies were seen moving on the floor.

- Eleven (11) minutes and eighteen (18) seconds into the footage, the subject was placed into the restraint chair. The subject could be seen leaning forward. At that same time, a deputy could be seen grabbing the subject under their chin area.
- The subject was observed to have dark hair and be wearing a black T-shirt and it was confirmed to be Evangelista.

- Evangelista was wheeled out of the common area and out of the camera's view.
- Thirty (30) minutes and fifty-seven (57) seconds into the footage, three (3) medics were seen entering the common area from a door located at the one (1) o'clock position on the camera footage.







**ADDITIONAL FACTORS FOR EVALUATING THE VIDEO RECORDINGS**

There are numerous other factors that need to be considered when reviewing and evaluating the videos and audio recordings of this incident. Those factors are:

A. Video recording devices record within the video and sound capabilities available, and they record objectively. Video recordings lack the history, perspective, and interest of the people involved. The positions, angles, obstacles, lighting, and distance from the incident are also factors that need serious consideration.

B. Video recording devices also record more information about a particular scene or incident than the person(s) involved in the incident can process during the critical incident. Video recording devices rarely record an event from the same perspective of the officer. It captures the action but not the perception, decision making, focus, or intent of the officer. Video recordings often miss tactile cues or other actions of a subject.

C. The speed of the incident is remarkable. The speed and complexity of rapidly evolving situation(s) that occur during use of force encounters are difficult concepts to comprehend by only watching the video.
