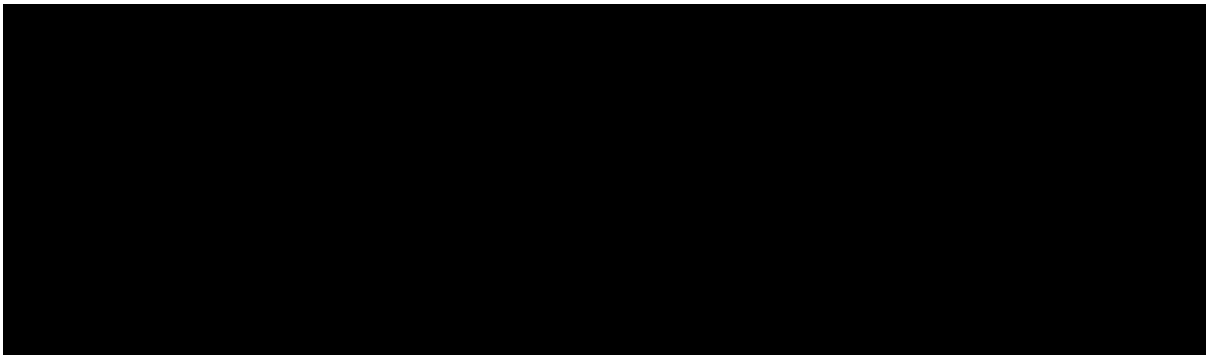
Narrative:

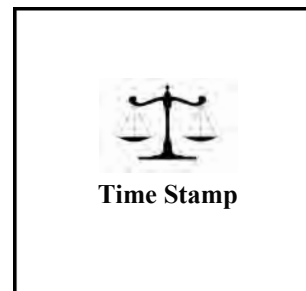

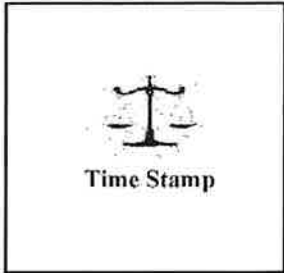
