Narrative:

On Monday, March 2, 2026, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Douglas Burke (Burke) obtained a Search Warrant from the Summit County Court of Common Pleas to execute a Search Warrant for a Samsung Android Galaxy S24 Cell Phone belonging to Ricardo Yuuki Davis's (Ricardo) with BCI Evidence Number 019, P00020-1046774. This would have been in reference to the Officer-Involved Critical Incident (OICI) involving Ricardo on Tuesday, February 24, 2026. The Samsung Android Galaxy S24 Cell Phone was provided to the Ohio BCI Cyber Crime Unit (CCU) on March 2, 2026, to perform and execute a physical extraction of the data on the Samsung Android Galaxy S24. Throughout the initial investigation, there had been a passcode located for the cell phone of (6608) to Ricardo's Samsung Android.

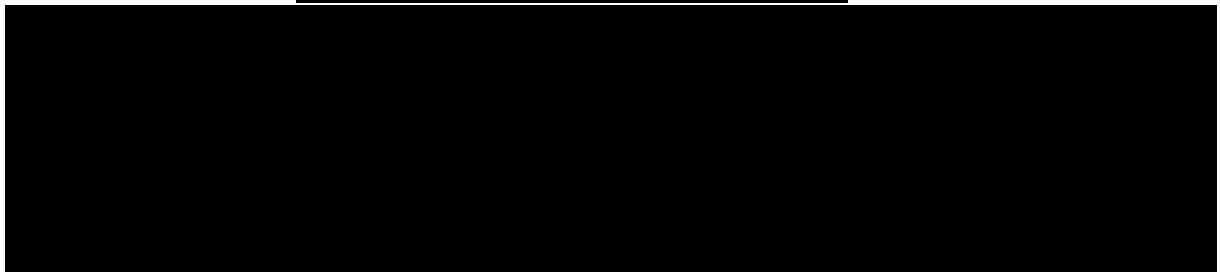
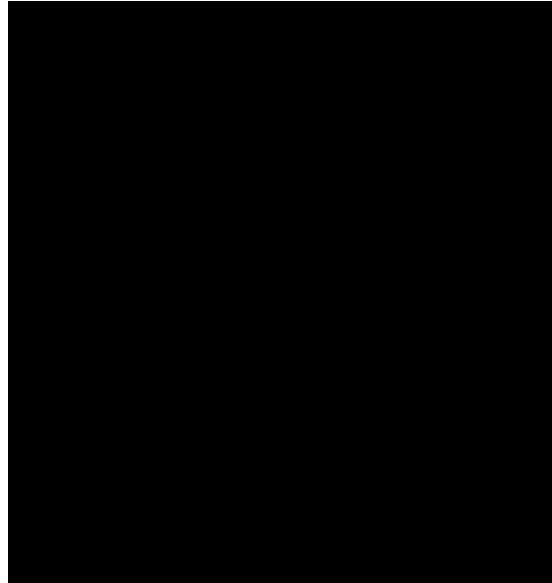
