Narrative:

On March 2, 2026. Ohio Bureau of Criminal Investigation (BCI) Special Agent John Tingley (SA Tingley) reviewed the Parma Police Department (PPD) Computer Aided Dispatch (CAD) report [REDACTED] related to the February 24, 2026, Officer Involved Critical Incident (OICI) which occurred at 10810 Brookpark Road, Brooklyn, Cuyahoga County, Ohio.

The listed CAD entries do not list all of the CAD entries contained in the report that covered the time before, during, and after the OICI. Rather, the entries listed document the CAD entries that were deemed by the author to be the most relevant and useful in obtaining an understanding of the PPD radio traffic from both the officers and dispatchers related to the OICI.

The PPD CAD Report Number is [REDACTED] and lists a date and beginning time of February 24, 2026, at 14:48:15 hours.

The following excerpts are taken directly from the PPD CAD Report and are placed in order from the earliest to the latest to assist with the understanding of the events that occurred regarding the OICI.

The listed excerpts are also shown as a word for word copy of the entries made by the PPD Dispatchers and appear as they are documented in the PPD CAD Report.
