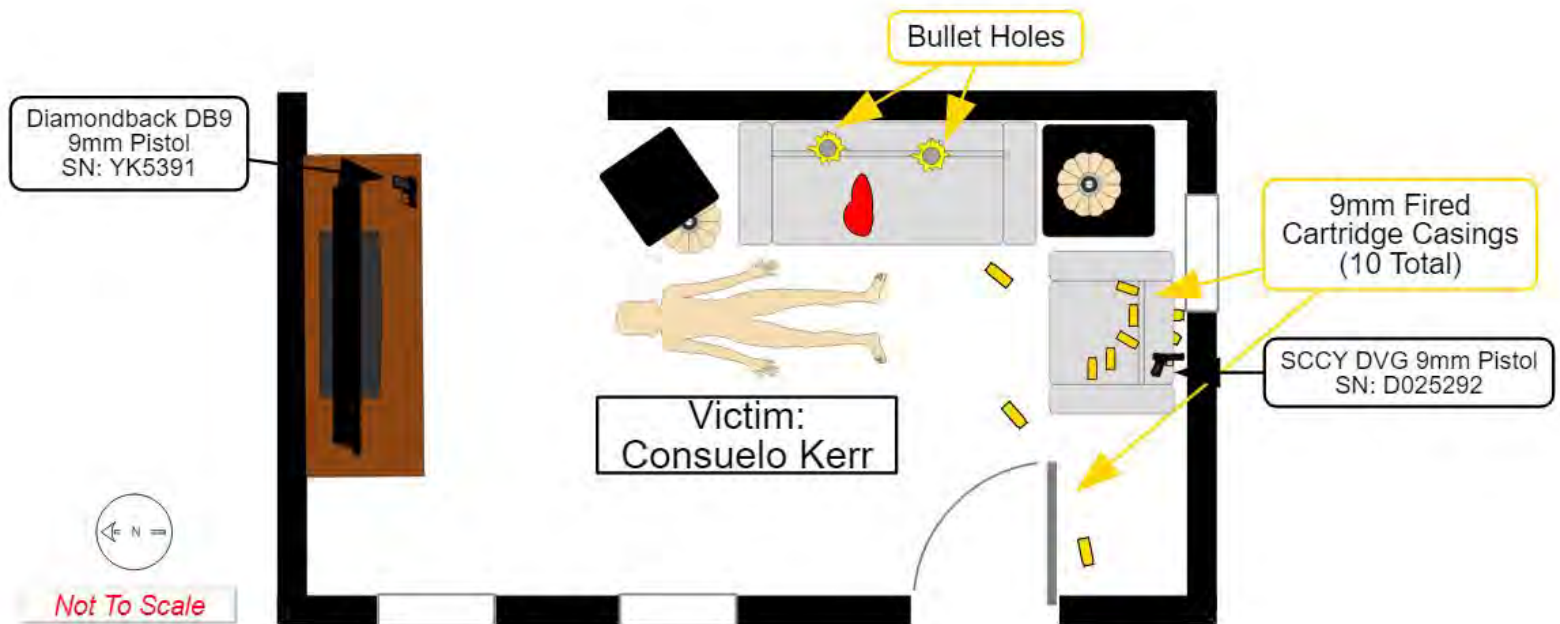
# Overview of Scene 3013 Mohawk Street

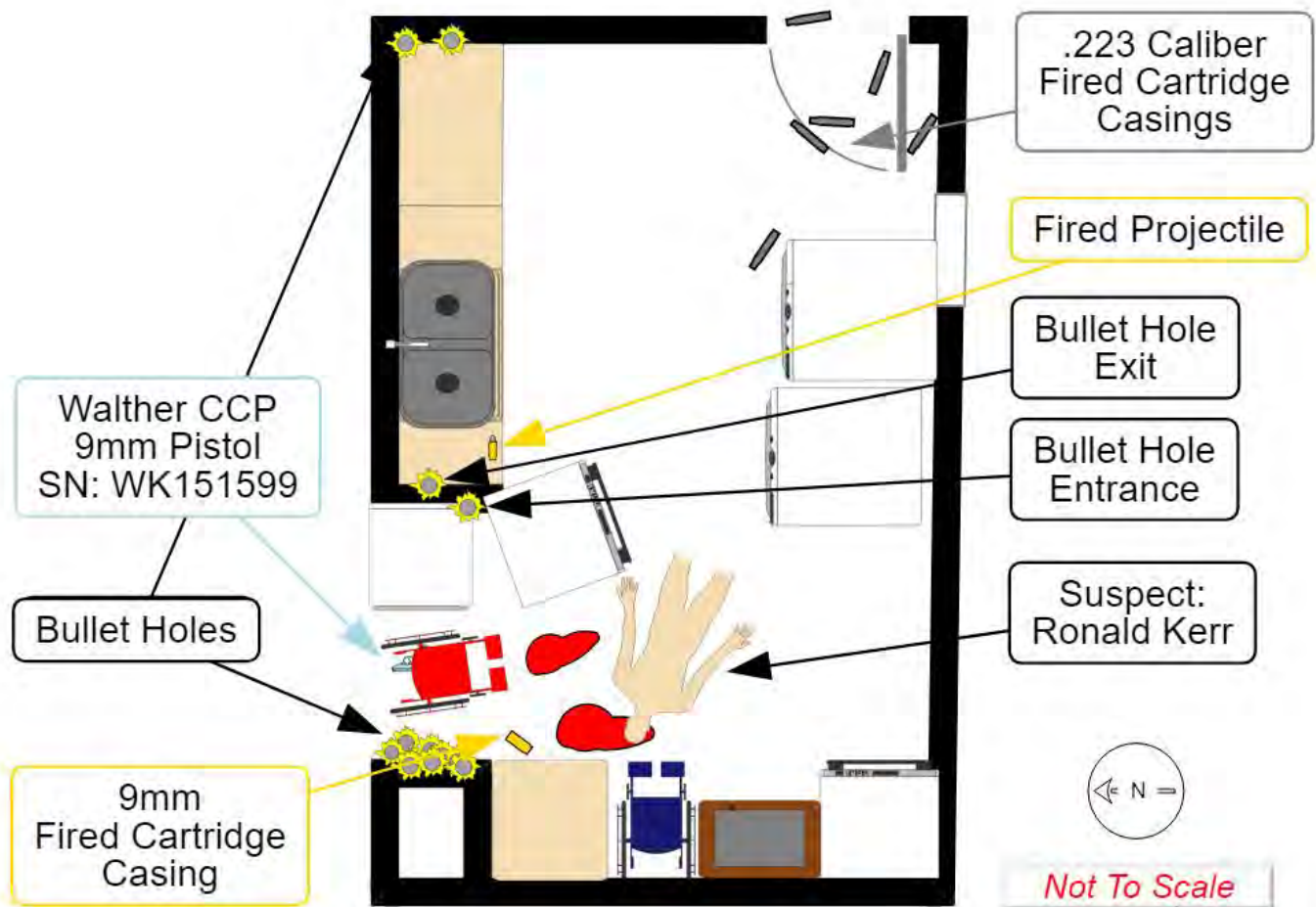
# 3013 Mohawk Street Living Room


