Narrative:

On September 20, 2023 Ohio Bureau of Criminal Identification and Investigation (BCI) Special Agent Ryan Scheiderer (SA Scheiderer) served TextNow Inc. (TextNow), a subpoena for records associated with information BCI Cyber Crimes Unit agents obtained from a partial forensic extraction of a cellular telephone thought to belong to Ta'Kiya Young (Young). Agents believed this information was related to TextNow and could help identify any accounts associated with Young (see subpoena for the target information).

On October 17, 2023 SA Scheiderer received the requested records from TextNow and they are attached to this report and available for review. TextNow did have an account associated with Young with the telephone number 614-943-4257, username: "kiya.young", email: "kiyayoung1@gmail.com", and it was activated on February 02, 2018.
