**Narrative:**

On Friday, December 20, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Joseph Goudy received requested records and recordings from Liberty Township Police Department (LTPD) Detective Jeff Palmer (Palmer). SA Goudy had previously requested all dispatch records, audio recordings (radio, 911, and phone), mobile data terminal (MDT) communications, and any other dispatch/communications-related information for December 16, 2024 relevant to the shooting incident. As a result of that request, the following items were received and reviewed:

**Computer Aided Dispatch (CAD) Records:**

The LTPD CAD Report documented times and personnel assigned to the call. The report contains the dispatch, en route and arrival times of the officers who responded to the incident. The call was initiated at 14:40:00. The call type was entered as "Suspicious Vehicle." The CAD Report has been attached to this report for additional details.

**Radio Traffic Recordings:**

The radio traffic provided included 226 radio transmissions. Each recording was titled with the date and time of the transmission. A text document titled, *Exported MetaData2024-12-16 at 14.37.53*, was provided with the recordings and contained identifying data for each of the recorded radio transmissions and the data. The table below contains the radio data and content of the radio traffic for the transmissions believed to be most relevant to the actual shooting incident.

Trauma medical applied to the wound. We are stabilizing, waiting on fire.		

The remainder of the radio transmissions included radio traffic from numerous responding officers and supervisors. The content of those radio transmissions included information related to the management of the critical incident after the shooting incident occurred. There was also radio traffic for unrelated calls for service that was not relevant to the shooting incident.

**Mobile Data Terminal (MDT) Communications:**

No MDT records relevant to the shooting incident were provided by LTPD.

**FLOCK Camera Hit:**

A document was provided containing the FLOCK camera hit that originally alerted LTPD officers to the stolen vehicle driven by the involved subject, Jason Cain. The FLOCK camera hit originally alerted to the stolen license plate affixed to the vehicle.

The “alert details” included the license plate (Ohio registration KMQ4492), make, model and color of the vehicle. A photo was also taken of the vehicle as it traveled north on Belmont Avenue at Gypsy Road. The date and time of the FLOCK hit was Monday, December 16, 2024, 07:37:01 PM UTC (02:37:01 PM EST).

The records received were attached to this investigative report. The audio recordings were uploaded to Evidence.com and were placed in the folder labeled, “Reference Item F – Dispatch Recordings.” Please refer to the reference item attachments for further details.


