Narrative:

On Wednesday, December 18, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) John Tingley (SA Tingley) received video footage from Shelby Police Department (SPD) Chief Lance Combs. SA Tingley was informed that the videos contained footage from the body cameras recorded by SPD Sergeant Sean Nolen (Nolen) related to the officer involved critical incident which occurred on December 7, 2024 at 234 Mansfield Avenue, Shelby, Richland County, Ohio.

The listed narrative is a synopsis of the activities and conversations recorded on SPD Sergeant Nolen's body worn camera (BWC) and only record those activities which the author deems to be the most relevant. Furthermore, the narrative does not cover all of the activities or conversations of Sergeant Nolen, other members of the SPD, or with members of the Shelby Fire Department (SFD) which were recorded. Nor is the synopsis a word for word translation of the conversations or comments made by Sergeant Nolen, other members of the SPD, or members of the SFD. It is suggested that the full recordings be reviewed to clarify any content or contextual questions regarding the information documented in the narrative.

It should also be noted that the attempts to obtain still photographs taken directly from the BWC video were unsuccessful as the video when stopped, was blurry and all attempts at still photographs taken from the video were also blurry.

SA Tingley reviewed the video recordings from Sergeant Nolen and noted the following:

The video is 00:46 in length and begins at 23:27:06 hours on December 7, 2024, as Sergeant Nolen was driving in an SPD cruiser.

At approximately 23:27:21 hours, Sergeant Nolen arrived at the Arby's restaurant at the incident location and exited his cruiser.

At approximately 23:27:29 hours, Sergeant Nolen entered the Arby's restaurant through the south customer entrance.

At approximately 23:27:33 hours, Sergeant Nolen walked to where SPD Officer Ewing was providing first aid to Tyler Jacobs and checked on Officer Ewing.

At approximately 23:27:45 hours, Sergeant Nolen contacted SPD Sergeant Kocher. Sergeant Nolen then escorted Sergeant Kocher out of the Arby's restaurant and walked him to a waiting SFD ambulance which was parked near the south customer entrance.

The video then concluded with Sergeant Kocher preparing to enter the ambulance.
