Narrative:

Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Cory Momchilov (Momchilov) was requested to review prior law enforcement contact reports involving Christian Alexander Tyson Thomas (Thomas). SA Momchilov reviewed reports obtained from the Cleveland Heights Police Department and documented the following:

Incident Report: January 22, 2024 January 22, 2024 Offenses: Obstructing Official Business, Resisting, Found Property, Walking on Roadway.

Narrative

During the Evening of Monday, Jan.22nd 2024 at approximately 1949hrs. Det. Laurello advised Officers via police radio of a suspicious male in the area of Cleveland Hts. Blvd and Glenwood. Information relayed as a male walking in the roadway and further described as having short dreads and a black jacket, a similar description to a party of interest regarding incident

As unit converged on the area I began checking Glenwood w/b from Cleveland Hts. Blvd. As I approached the area of Glenwood and Inglewood I was able to observe a party walking directly in the middle of the road. The male was wearing tan colored pants and a black jacket. I approached the male in my marked police cruiser (c-1160). Contact was made with the male, later identified as Christian Thomas.

During my encounter with Christian I repeatedly advised him the reason of the stop which was due to observing him walking in the roadway. I began explaining to Christian how it is illegal to do so while simultaneously directing his attention towards the sidewalk which was shoveled and clear of any obstructions. Immediately after, Christian stated " I'm going home" and began walking away from me. I advised Christian that he was not allowed to leave. Christian began picking up his pace and eventually started fleeing from Officers on foot. Verbal commands to stop were given to Christian as he was running however, he refused to comply.

Christian began running in a w/b direction on Glenwood Rd. Information was relayed to support units as they began responding to the area. Christian followed a path w/b to Yellowstone Rd. and continued in a n/b direction. Christian eventually ran between some residences and was subsequently taken into custody in the rear yard of 1315 Yellowstone. It should be noted, upon my arrival in the rear yard of 1315 Yellowstone, Christian was actively resisting Officers and would not present his arms or turn over on his stomach as he was instructed to do. See Ofc. Basista's statement for further.

After Thomas was secured in the rear of c-1165 an area check was performed by several Officers which spanned from the rear of 1315 Yellowstone Rd. to the original location where the male was observed walking in the roadway at Cleveland Hts. Blvd. and Glenwood Rd. The area check revealed negative findings with respect to the loaded magazine found on Thomas during his apprehension.

Thomas issued BK205034 for Walking in the Roadway (371.05A).

Narrative

On 02/17/2023 at 0306 hours officers responded to 3857 Montevista Rd. for a report of a suspected overdose.

Upon arrival officers observed the subject Nehemiah Reed, laying on the ground in the living room unconscious but breathing. Officers administered 6 doses of 4mg of narcan totalling 24 mg but Reed did not regain conciousness. Cleveland Heights Fire Department arrived on scene and transported Reed to Rainbow babies and children's hospital. Reed's mother Jaime Takacs was on scene but was asleep upstairs at the time of the incident and was going to respond to the hospital in her personal vehicle.

The reporting party was Reeds friend who was identified as Christain Thomas. Thomas stated he took half of a percocet, Reed took two totalling 60mg about 3 hours ago. Thomas and Reed both sat down on the couch, that is when Thomas became unconscious. Thomas returned to the living room after using the restroom to find Reed was still on the floor unconscious so Thomas attempted to wake him up by shaking him and calling his name. Reed was not responding so Thomas called 911. When officers asked about where he obtained the percocets he said he got them through the dark web and they were mailed to him, however he no longer has the package that it came in. Thomas advised us that Reed has taken 2 percocets from the same batch before but this is the first time he became unconscious.

Thomas stated he felt fine and did not want to go to the hospital. **Contacted Thomas's father so that** he could take custody of him since no one was going to be left at the residence to keep an eye on him.

The used narcan was disposed of at the station. Reed's cellphone was placed in airplane mode and booked as evidence in locker 5.

This report was fowarded to the crime suppression team for further.

Investigative Report

Title / Subject: OBSTRUCTION/EVIDENCE/PHO

On Monday January 22nd, 2024 around 1949 hours Detective Laurello requested marked Cleveland Heights Police units to check on a male walking in the roadway on Glenwood Rd near Inglewood Rd. Officer Psepolschi arrived shortly after and made brief contact with a male, later identified as Christian Thomas, in the middle of Glenwood Rd. Harris fled from Psepolschi westbound Glenwood Rd on foot.

Myself and Officer Franczak arrived on scene just as Thomas was fleeing on foot. I observed Thomas running westbound on Glenwood Rd before turning northbound on Yellowstone Rd. Thomas continued running northbound on the east side of the street before diagonally running across the front yard of 1321 Yellowstone Rd and eastbound up the driveway of 1315 Yellowstone Rd. I began to give chase on foot at this point where I was able to make contact with Thomas, who had fallen in the snow, in the backyard of 1315 Yellowstone Rd.

I ordered Thomas to put his hands behind his back several times which he refused to do. Eventually several officers arrived and assisted with detaining Harris, which took about 60-70 seconds to get handcuffed due to him refusing to turn over and place his hands behind his back.

During our attempt in handcuffing Thomas, a Glock magazine fell off of his person (unknown which article of clothing it had been concealed in). The Glock magazine is a 10-capacity black magazine and had three (3) inserted brass 9mm rounds. The magazine was returned to the Cleveland Heights Police Department, photographed with the B-Platoon shift camera, and booked into evidence. No firearm was located.

Investigative Report

Title / Subject: OVERDOSE



On 02/17/2023 at 0306 hours officers responded to 3857 Montevista Rd. for a report of a suspected overdose.

Upon arrival officers observed the subject Nehemiah Reed, laying on the ground in the living room unconscious but breathing. Officers administered 6 doses of 4mg of narcan totalling 24 mg but Reed did not regain conciousness. Cleveland Heights Fire Department arrived on scene and transported Reed to Rainbow babies and children's hospital. Reed's mother Jaime Takacs was on scene but was asleep upstairs at the time of the incident and was going to respond to the hospital in her personal vehicle.

The reporting party was Reeds friend who was identified as Christain Thomas. Thomas stated he took half of a percocet, Reed took two totalling 60mg about 3 hours ago. Thomas and Reed both sat down on the couch, that is when Thomas became unconscious. Thomas returned to the living room after using the restroom to find Reed was still on the floor unconscious so Thomas attempted to wake him up by shaking him and calling his name. Reed was not responding so Thomas called 911. When officers asked about where he obtained the percocets he said he got them through the dark web and they were mailed to him, however he no longer has the package that it came in. Thomas advised us that Reed has taken 2 percocets from the same batch before but this is the first time he became unconscious.

Thomas stated he felt fine and did not want to go to the hospital. **Contacted Thomas's** father so that he could take custody of him since no one was going to be left at the residence to keep an eye on him.

The used narcan was disposed of at the station. Reed's cellphone was placed in airplane mode and booked as evidence in locker 5.

This report was fowarded to the crime suppression team for further.
