
On September 25, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Nick Valente (Valente) began compiling and reviewing background information on George Appleby (Appleby), subject of the officer-involved shooting in Alliance, Ohio, on September 3, 2023. The information included researching and reviewing Appleby's computerized criminal history (CCH), court records (if applicable), open/closed-source database inquiries and social media posts. The information gathered was obtained from the BCI Criminal Intelligence Unit and through open source internet searches.

SA Valente reviewed the information and noted the following:

Computerized Criminal History:

At the time of his death, Appleby had an active warrant for his arrest. Specifically, the arrest warrant originated out of the Stark County Sheriff's Office for absconding from the terms of probation after pleading guilty to a felony offense of domestic violence.




