## Search Warrant Obtained

Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) John Tingley (Tingley) drafted a search warrant for the cell phone records of James Sheets, relative to the officer-involved critical incident which occurred on Friday, April 1, 2022.

On Thursday, April 28, 2022, SA Tingley met with Summit County Court of Common Pleas Judge McLaughlin in Judge McLaughlin's chambers. Judge McLaughlin reviewed the search warrant, search warrant affidavit, motion to seal (search warrant, affidavit, inventory and the listed motion) and order to seal (search warrant, affidavit, inventory and the listed motion). Accordingly, at approximately 0945 hours, Judge McLaughlin signed the search warrant and the order to seal.

## Search Warrant Executed

On Thursday, April 28, 2022, at approximately 1155 hours, SA Tingley executed/served the aforementioned search warrant by submitting the phone described in the search warrant to the BCI Richfield Cyber Crimes Unit.

During the search, the following items of potential evidence were seized:
