Narrative:

On June 29, 2022, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Matthew Armstrong (Armstrong) collected additional evidence related to the June 27, 2022, officer-involved shooting in Akron, Ohio. The evidence consisted of a projectile recovered from an entrance area on the south side of the Bridgestone Center for Research and Technology.

Earlier that day, Bridgestone Security Specialist Randy Hicks (Hicks) called SA Armstrong and indicated an employee had discovered a projectile near an entrance to the building. At approximately 1300 hours, SA Armstrong met with Hicks in his office. Hicks turned over one projectile which was packaged in a ziplock bag.

Hicks explained, on June 29, 2022, at approximately 0639 hours, Bridgestone Lab Technician Zackery Bennett located the projectile on the sidewalk near the entrance at the southeast corner of the Bridgestone Center for Research and Technology building. He picked it up with a paper towel and turned it over to Hicks, who placed it in the ziplock bag. An evidence receipt was completed and has been attached to this report.

Hicks also provided SA Armstrong with printed photographs of the location where the evidence was located. SA Armstrong requested the photographs in digital form. On June 30, 2022, SA Armstrong received the photographs from Hicks, via a secure link. They have been uploaded to Matrix and attached to this report.

SA Armstrong transported the projectile to the BCI Richfield office, where it was placed in evidence as Item #194.
